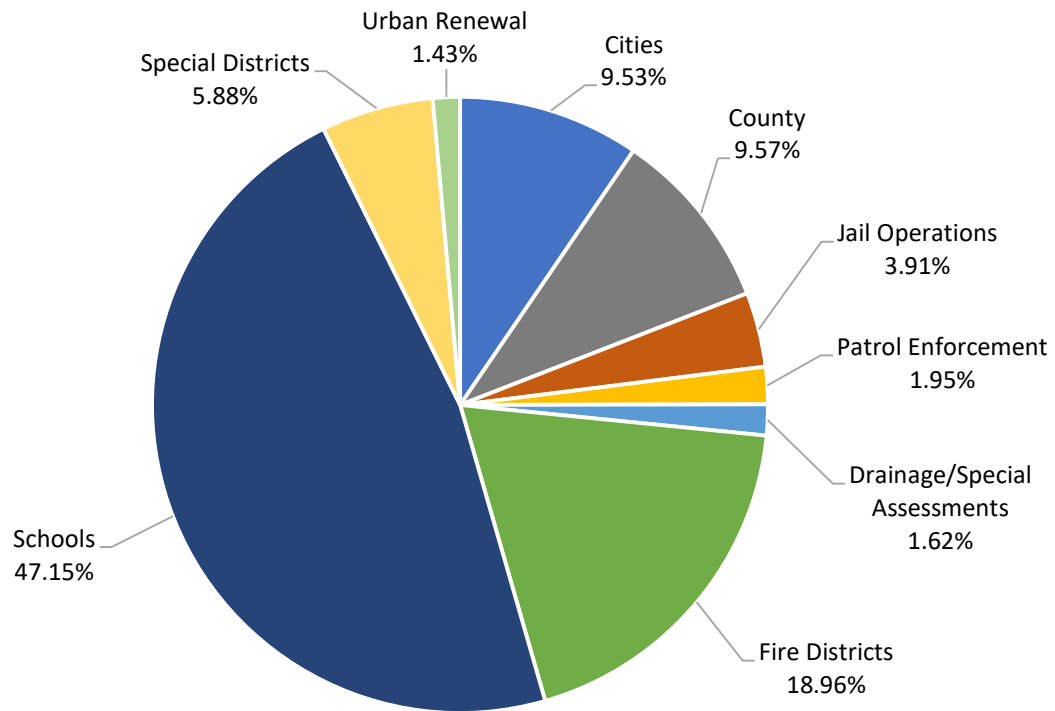

EXPLANATION OF URBAN RENEWAL TAX INCREMENT FINANCING

The Oregon Constitution and Statutes allow cities and counties to establish Urban Renewal Districts for the purpose of improving specific areas, or “Plan Areas”, that contain deteriorated buildings and/or lack adequate infrastructure, or “blight” as it is commonly called. Urban renewal agencies can take on special projects, or “plans”, like improving roads, bringing sewer and water to industrial sites, developing public buildings, such as fire stations, and many other worthwhile activities.

By incurring debt to pay for these improvements, it is expected that property values within the Plan Area will increase due to private investments that would not otherwise occur. The property taxes from this increase in value, called “increment”, is then given to the urban renewal agency to pay off the debt. If there is no increase in assessed value, the urban renewal agency does not collect any revenue. Local taxing districts, such as the county, city, fire district, school district and others, continue to receive the property taxes from the assessed value the district had before the urban renewal plan area plan was formed. This value is called the “frozen value”. The increase in the value of the plan area above the frozen value is called “excess value”.

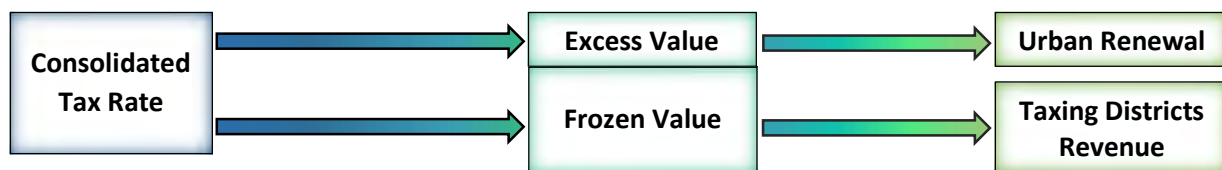
Impact on Property Owners

Even though the assessed value in the plan area is frozen, property owners are still taxed the same way as before. New investment is taxable the same as all other property in the County (unless the property qualifies for exemption or special assessment under other programs). All taxing districts have a fixed tax rate for operating purposes. Those fixed tax rates for taxing districts that reside within the plan area are reduced by the increment necessary for the agency to receive the revenue attributed to the excess value. There is no impact on property owners, either positive or negative. The total tax amount remains the same.

Impact on Taxing Districts

With a rate-based property tax system the impact on taxing districts is just the opposite for what it is for property owners. Like the frozen value, a taxing district’s operating property tax revenue from the plan area would be frozen since the rate cannot change. (The district could still realize an increase in property taxes from outside the plan area.) Once the debt is paid off and the Plan Area is dissolved, assessed values increase due to the private investment, and taxing districts receive property taxes from the increased assessed value.

Total Consolidated Tax Rate X Assessed Value in Urban Renewal Area = Tax Revenues



Only the taxing districts that reside within the urban renewal plan area are impacted by urban renewal. However, the impact is spread across the shared property. If the urban renewal district was established by the county, then the entire county is considered to be the shared property.

Once the total revenue for the urban renewal district is known, each district within the area has its operating tax rate reduced by the increment tax rate necessary to collect that revenue. These rates are applied to all properties within each of the affected districts’ boundaries.

Measure 5 Compression

Tax rates are applied to the tax assessed value when taxes are calculated. Each district's rate is categorized as education, general government or non-limited in order to calculate the Measure 5 tax rate limitations. While Measure 50 created permanent operating rates for taxing districts to be applied to the tax assessed value, Measure 5 tests for the category limits of \$5.00/\$1,000 value for education and \$10/\$1,000 value for general government. The urban renewal increment, which comes from all districts within an urban renewal plan area, is subject to the category limit for which the funds are used and is added into the appropriate category for tax calculation. These consolidated category limits are tested against the real market value or the specially assessed value (often referred to as the M5 Value) of the property to determine if compression is necessary.

Following is an example of how to test for Measure 5 Compression:

Total Real Market (M5) Value = \$120,000 Total Assessed Value (AV) = \$100,000

For tax code area 02-01, the Measure 5 limitations for education and general government would be:

Education: \$120,000 M5 Value x \$5.00/\$1,000 = \$600.00 M5 Tax Limit
Government: \$120,000 M5 Value x \$10.00/\$1,000 = \$1,200.00 M5 Tax Limit

The Measure 50 tax is calculated using the full tax rate and the Assessed Value:

Education: \$100,000 AV x \$5.4563/\$1,000 = \$545.63 M50 Tax
Government: \$100,000 AV x \$8.0368/\$1,000 = \$803.68 M50 Tax

Now compare the two calculations to see if compression is necessary. For both the education and general government tax, the M50 tax is lower than the M5 tax limit, so there is no compression.

Another example of compression using tax code area 02-01:

Total Real Market (M5) Value = \$105,000 Total Assessed Value (AV) = \$100,000

For tax code area 02-01, the Measure 5 limitations for education and general government would be:

Education: \$105,000 M5 Value x \$5.00/\$1,000 = \$525.00 M5 Tax Limit
Government: \$105,000 M5 Value x \$10.00/\$1,000 = \$1,050.00 M5 Tax Limit

The Measure 50 tax is calculated using the full tax rate and the Assessed Value:

Education: \$100,000 AV x \$5.4563/\$1,000 = \$545.63 M50 Tax
Government: \$100,000 AV x \$8.0368/\$1,000 = \$803.68 M50 Tax

The general government category is still below the M5 government category limit, however, the education tax in this case is \$20.63 more than M5 allows, so education taxes are compressed. This means the M50 tax amount for each district within the education category on this tax statement will be reduced proportionately so that the total does not exceed \$525.00. This is done by dividing the M5 Limit by the M50 Tax and apply the resulting ratio to each district in that category. The compressed tax results in tax revenue loss to the district.

\$525.00/\$545.63 = 0.9621904954 M5 Limit Ratio

Columbia County Changed Property Ratios

A Changed Property Ratio (CPR) for each property type is calculated annually to calculate the Maximum Assessed Value attributable to the Real Market Value of 'changed' property that is added due to new property, new improvements to property, subdivided or partitioned property, or property that is disqualified from exemption or special assessment.

For each property type countywide, the average maximum assessed value is divided by the average real market value of 'unchanged' properties to determine the ratio, not to exceed 1.00, to be applied to the real market value of 'changed' properties.
