SUBJECT: Re-establishing a Committee for Citizen Involvement (CCI)

DATE: September 20, 2018

SUMMARY:

Our Comprehensive Plan Part II addresses Citizen Involvement. The Comprehensive Plan states that a Committee for Citizen Involvement (CCI) should be comprised of three members of the Planning Commission, two members from the Citizen Planning Advisory Committees (CPAC) and two interested citizens. Policy 8 states the CCI Committee should be comprised of nine (9) county residents broadly representative of geographic areas and interests. The CCI group would re-evaluate the county's citizen involvement program, consisting of CPACs in 7 areas of the county, their boundaries, the CPAC rules and procedures and election process. The CCI could consider a totally new citizen involvement program. I expect the CCI to meet, develop ideas, discuss alternatives and provide recommendations to the Planning Commission and Board of Commissioners necessary to initiate legislative amendments to the Comprehensive Plan. The CCI is a permanent county sanctioned committee.

Attached is a list of potential CCI members interested in citizen participation that Staff has put together while evaluating the County's citizen participation program and conducting 2018 CPAC elections. The list is composed of three sections, <u>I:</u> Planning Commission members assigned to the committee; <u>II.</u> Those persons who have been elected to a CPAC; and <u>III.</u> Interested Citizens who have expressed interest in serving on the CCI. The list provides for a good representation of geographic areas excepting the Scappoose area and the Vernonia area which only have one person each.

RECOMMENDATION:

The Planning Commission recommended four names from the entire list of potential CCI Membership (not including PC members). These citizens have been at every meeting concerning citizen's involvement: Jason Resch, Stephen Topaz, Al Petersen and Don Campbell.

Staff recommends appointments of: 1) the three Planning Commission members listed above, 2) the two citizens from a CPAC: be Rosemary Lohrke from the Scappoose area with a long history of serving on a CPAC; and, Tammy Maygra from Tide Creek Canaan Neighborhood, also with a long history of serving on a CPAC; and, 3) the two interested citizens: be Jason Resch from the Warren area and Steve Calhoun from the Vernonia area.
