COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

April 14, 2004

The Columbia County Board of Commissioners met in scheduled session with Commissioner Rita Bernhard, Commissioner Anthony Hyde, and Commissioner Joe Corsiglia, together with John Knight, County Counsel and Jan Greenhalgh, Board Secretary.

Commissioner Bernhard called the meeting to order and led the flag salute.

MINUTES:

Commissioner Hyde moved and Commissioner Corsiglia seconded to approve the minutes of the April 7, 2004 Board meeting; and April 7, 2004 Staff meeting. The motion carried unanimously.

VISITOR COMMENTS:

Peggy Crisp, Warren, attended the Fair Board meeting last Monday and is concerned that there is no communication with the Fair Board on the issue of Asburry Acres. The Fair Board doesn't even want the ball fields on that property. They said it was their property and if they need it for camping, the baseball people will have to get off the property, even if it's not during Fair time. The Board needs to communicate to the Fair Board what the deed and will says for the use of that property.

Commissioner Hyde agrees that there needs to be communication with the Fair Board. He informed the Fair Board that, during their 4-H event, they will have use of the property that they traditionally use. He spoke with some people after the meeting and feels there can be resolution but there clearly needs to be more discussion on where the ball fields will be placed and how it will effect the whole use of the property. Commissioner Hyde told the Fair Board to review the plans and submit their comments in writing to the Board.

Commissioner Bernhard read the consent agenda in full. With that, Commissioner Hyde moved and Commissioner Corsiglia seconded to approve the consent agenda as follows:

- (G) Agreement with Ed Bergman Trucking, Inc. for the logging of Camp Wilkerson.
- (H) Reconveyance of Trust Deed by Craig and Teresa Staggenborg for the payoff of a loan through the Columbia County Regional Housing Rehabilitation Program.

SPWF LOAN AGREEMENT FOR THE SOLID WASTE TRANSFER STATION:

Commissioner Hyde moved and Commissioner Corsiglia seconded to ratify approval of the Special Public Works Fund Loan Agreement, Project #J04007 for the Columbia County Solid Waste Transfer Station. The motion carried unanimously.

APPOINTMENTS TO CLATSKANIE-QUINCY CPAC:

Based on the recommendation from staff, Commissioner Hyde moved and Commissioner Corsiglia seconded to reappoint Gary Leinonen, Sharon Coates, Rich Larsen and Margaret Magruder and appoint Matt Williams to the Clatskanie-Quincy CPAC. The motion carried unanimously.

COMMISSIONER BERNHARD COMMENTS:

Commissioner Bernhard worked the Easter Egg hunt held out at the fairgrounds on Saturday. It was a very well organized community event. There were around 2,600 people who attended.

Yesterday, she also attended the 911 awards ceremony at the Communications center to honor the people who have made contributions to the 911 system. The Road Department received a special award.

COMMISSIONER HYDE COMMENTS:

Last week, he was confirmed by the full Senate on his appointment to the Oregon Economic Development Commission. This is a good opportunity for the economy of Columbia County.
