MINUTES

April 28, 2004

The Columbia County Board of Commissioners met in scheduled session with Commissioner Rita Bernhard and Commissioner Joe Corsiglia, together with John Knight, County Counsel, and Jan Greenhalgh, Board Secretary. Commissioner Hyde was not present.

Commissioner Bernhard called the meeting to order and led the flag salute.

COMMISSIONER BERNHARD COMMENTS:

Commissioner Bernhard attended a business forum in Salem sponsored by AOC. They discussed the progress made since this process started. Discussion was also held on government services, the budget crisis, combining services, and basic ways to cut costs.

She attended the City/County meeting in Rainier last night. It was very well attended. Discussion was held on economic opportunities in the county. A representative from USG was present and to talk about their company and how well they are doing. They are even looking at expanding and adding another shift. Also talked about the Port Westward development.

On Saturday, she participated in the SOLV cleanup projects. Weather was good and a lot of people helped out.

On Friday, she road along with the Electrical Inspector. They did a number of inspections throughout the county. That was very educational for her.

COMMISSIONER HYDE COMMENTS:

Commissioner Hyde was attending an Oregon Forestry Symposium and was not present for the meeting.

COMMISSIONER CORSIGLIA COMMENTS:

Commissioner Corsiglia attended the Grant Watts auction on Saturday. He also visited the cleanup at the Historical Society in Vernonia.

He has been working on an exciting project this week with Port officials. There is a potential of locating a NASCAR track at the Meier site in Scappoose. He will be attending the Port meeting this morning to continue discussion on the details. This is not a done deal yet, but he will be continuing to work on this project. There is a tremendous amount of money involved here. The ISC (International Speedway Corporation) is worth about \$750 million. He is excited to be working on this potential opportunity.

He has stepped away from voting on any decision on how the Board decides to handle this request.
