### MINUTES August 18, 2004

#### **MINUTES:**

Commissioner Corsiglia moved and Commissioner Hyde seconded to approve the minutes of the August 10, 2004 Work Session; August 11, 2004 Board meeting and August 11, 2004 Staff meeting. The motion carried unanimously.

The motion carried unanimously.

### **DENY APPEALS OF ACCESS APPROACH PERMIT DEPOSIT:**

Sarah reviewed the appeals by Seabold Homes and Monty Hughes. Seabold Homes believe they are not required to do this work however, Sarah feels it is appropriate to grant a 60 day extension anyway. Monty Hughes has requested an extension. After discussion, Commissioner Corsiglia moved and Commissioner Hyde seconded to deny the appeals of the Access Approach Permit Deposit Forfeitures for Seabold Homes and Monty Hughes, but grant a 60 day extension in which to complete the work and authorize Commissioner Hyde to sign the letter. The motion carried unanimously.

Regarding Richard Niemi, he no longer lives at the home and doesn't even own it so he will not be doing the work. With that, Commissioner Corsiglia moved and Commissioner Hyde seconded to deny the Appeal of the Access Approach Permit Deposit Forfeiture for Richard Niemi and authorize Commissioner Hyde to sign the letter. The motion carried unanimously.

#### **BLAHA ROAD:**

Dave Hill explained that letters have been sent out to all effected property owners giving them time to object to the road improvements. A few have called but there are no serious objections. Colleen DeShazer is also in agreement. Dave asked for authorization to move forward with the bids and plans on these improvements. Sarah stated that should be done by Board Order and she will prepare that for next weeks agenda. Dave stated that once bids are received, he will bring them back before the Board for approval.
