### COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

### MINUTES

#### October 26, 2005

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde, Commissioner Joe Corsiglia and Commissioner Rita Bernhard, together with John Knight, County Counsel, Sarah Hanson, Assistant County Counsel and Jan Greenhalgh, Board Secretary.

Commissioner Hyde called the meeting to order and led the flag salute.

#### MINUTES:

Commissioner Bernhard moved and Commissioner Corsiglia seconded to approve the minutes of the October 19, 2005 Board meeting. The motion carried unanimously.

# AWARD TO PEABODY AND FULLER:

Commissioner Hyde asked both Deputy Peabody and Deputy Fuller here today to get a photo for the newspapers on the awards they received from the Marine Board. Both Deputies received the Marine Program of the Year Award and Deputy Peabody received the Marine Deputy of the Year Award. Further, Commissioner Bernhard moved and Commissioner Corsiglia seconded to approve the Crossing Agreement with the Portland & Western Railroad and authorize the Chair to sign. The motion carried unanimously.

Commissioner Hyde attended the annual RC& D meeting at Camp 18 last Thursday, which is an 8 county consortium. The Resource Advisor to the Governor was present to speak.

On Friday, he attended the ground breaking at Port Westward for the water system, which was a big event for Columbia County.

On Monday, he attended the City/County meeting in Columbia City, hosted by the Port of St. Helens, which was a good opportunity for the Port to apprise the cities of what is going on.

### COMMISSIONER CORSIGLIA COMMENTS:

Commissioner Corsiglia was at the Port last week to listen in on the interviews of the candidates for the vacant Port Commission position.

## **COMMISSIONER BERNHARD COMMENTS:**

Commissioner Bernhard reported on the Oregon Consortium meeting she attended last Thursday and Friday in Astoria.

She also attended the City/County dinner on Monday. She feels this is a good opportunity for everyone to speak about what is going on in their community.
