COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

July 26, 2006

The Columbia County Board of Commissioners met in scheduled session with Commissioner Joe Corsiglia, Commissioner Rita Bernhard and Commissioner Anthony Hyde, together with John Knight, County Counsel and Jan Greenhalgh, Board Secretary.

Commissioner Corsiglia called the meeting to order and led the flag salute.

MINUTES:

Commissioner Hyde moved and Commissioner Bernhard seconded to approve the minutes of the July 19, 2006 Board meeting. The motion carried unanimously.

VISITOR COMMENTS:

Joe Stevenson, 65390 Olson Road, Deer Island: He is the spokesman for a group of neighbors and property owners who want to voice their complaint and concerns about the Run 21 motorcycle event held last weekend. There was 72 hours of straight motorcycle noise, fowl language, music, and no fire safety measures that he could see. When he called the Sheriff's office on Friday night, he was informed that this group received a conditional use permit by the County Commissioners. He feels strongly that his rights, along with all of his neighbors rights, were stepped on and they deserve an apology and the assurance that this will not be allowed to happen again.

Lew Parshall, 33960 Butterfield Road, Deer Island: She has lived on Butterfield Road for 24 years and is pretty much the only house on Butterfield Road. The first camp site for this Run 21 was approximately 200 yards from her property. She doesn't feel that the Peterson's knew this was going to be the huge event that it was, but she is a little upset that they didn't inform her about it. The noise was constant. When she checked with someone from the event, they told her that all permits were obtained so she felt there was nothing she could do.

Terry Etter, Scappoose: On a different subject, Terry read a letter from her husband, William Etter, into the record that addressed the issue of two drug paraphernalia booths at the county fair. Commissioner Corsiglia stated that this was dealt with and that both booths were removed from the Fairgrounds by the Fair Board by Thursday night.

- (G) Appoint Gayle Lee to the Planning Commission to complete the term of Peter Brewer, term to expire on December 31, 2007.
- (H) Approve the reappointment of Cheryl Fantz and Charlotte Kocher to the Columbia Community Mental Health Board of Directors.
- (I) Approve the Temporary Liquor License for Silver Lining Catering August 12th event at the Fairgrounds.
- (J) Approve the Public Event Permit for MS 150 Bike Tour on August 6, 2006, subject to receipt of required deposit.

She spent a lot of time last week at the Fair and there were some issues that will be looked at by the Fair Board.

On Monday, she spent time with Dave Hill on the roads. Pittsburg Road was recently paved and looks very nice. She felt for the road crew having to work in the extremely warm weather. There are more paving projects scheduled for this year. They also visited Camp Wilkerson - very nice new cabins.

COMMISSIONER HYDE COMMENTS:

Commissioner Hyde also commented on the County Fair and the Cascade Grain ground breaking.

EXECUTIVE SESSION UNDER ORS 192.660(1)(h):

The Board recessed the regular session to go into Executive Session as allowed under ORS 192.660(1)(h). Upon coming out of Executive Session, Commissioner Hyde moved and Commissioner Bernhard seconded to deny the appeal by the Scappoose-Spitzenberg CPAC due
