#### **MINUTES**

# February 14, 2007

The Columbia County Board of Commissioners met in scheduled session with Commissioner Rita Bernhard and Commissioner Joe Corsiglia, together with John Knight, County Counsel and Jan Greenhalgh, Board Secretary. Commissioner Hyde was not present.

Commissioner Bernhard called the meeting to order and led the flag salute.

### **COMMISSIONER BERNHARD COMMENTS:**

Commissioner Bernhard spent Monday in Salem for a Rural Oregon Day - the Governor and Senators gave speeches. It was a day long program sponsored by The Oregon Consortium and Workforce Investment Board. Afterwards, they met with legislators. It was a very good day and a lot of good information was shared.

She attended a United Way retreat to meet and discuss the overall program and the possibility of consolidating the program with another county. It is becoming more difficult to get people to donate because of all the other programs out there. We are up to 85% of our goal so far this year.

On Friday, she and John Knight met with representatives from the Health District to discuss concerns that were brought up by the Board of Commissioners. Another meeting is being scheduled to continue those discussions.

On Thursday, she attended the Clatskanie PUD meeting. There were probably around 150 people who attended the meeting. There are certain deadlines that have to be met for the projects at Port Westward and there are concerns with the supply of power.

# **COMMISSIONER CORSIGLIA COMMENTS:**

Commissioner Corsiglia worked with the Natal and Mist granges on a fundraiser for a family whose house burnt.

He attended an LGAC meeting in Salem last Friday. They appear to have a different attitude now that they have more money.

The county budget doesn't look very good for the next fiscal year. Some tough decisions lay ahead on staffing and services.

There was no Executive Session held.

With nothing further coming before the Board, the meeting was adjourned.
