# COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

#### MINUTES

# February 25, 2009

The Columbia County Board of Commissioners met in scheduled session with Commissioner Rita Bernhard, Commissioner Anthony Hyde and Commissioner Earl Fisher, together with Spencer Parsons, Assistant County Counsel and Jan Greenhalgh, Board Secretary.

Commissioner Bernhard called the meeting to order and led the flag salute.

# **MINUTES:**

Commissioner Fisher moved and Commissioner Hyde seconded to approve the minutes of the February 18, 2009 Board meeting. The motion carried unanimously.

### **VISITOR COMMENTS:**

Scott Groves, 57218 Old Hill Road, Scappoose: Scott presented the Board with a letter he received from Roger Kadell regarding the loop hole in his nuisance complaint. To explain, this was a response to Scott's call to Commissioner Fisher regarding guns being fired near and towards his property. Again this weekend, the neighbor he has been complaining about for years, left all day and left the dogs out to bark all day. Roger has stated that he is unable to issue any nuisance violations until the issue of her license is finally settled. Scott feels it is totally inconceivable that something cannot be done on this continuing nuisance.

Commissioner Bernhard firmly stated that the Board has heard this complaint a number of times and the county is doing what they can under the current law and that counsel is working to see what can be done to rectify this matter. The Board is sympathetic to his situation, but the county is working on this and asked for his patience. Hopefully, something can be done fairly soon. Scott asked that the Board also look at the loop hole addressed in Roger's letter and encouraged the Board to get that fixed.

Mike Dennis, Oregon Aero, Inc., 59845 Oliver Heights Lane, St. Helens. Mr. Dennis read a letter he previously sent to the City of Scappoose and shared that with the Board here today. He is here with many of his colleagues who are affiliated with the Scappoose Airport to ask for the Boards help. Even in normal economic times, running a business successfully is challenging and these are certainly not normal times. All of us in the private sector are struggling. On behalf of his company, Oregon Areo, and the other businesses at the Scappoose Airport, they would like to thank the Scappoose City Council for its interest in the airport and for its willingness to explore all economic growth opportunities. Although the airport lies within the boundary of the City of Scappoose, it is owned and managed by the Port of St. Helens. Unfortunately, the Port has not demonstrated an interest in development at the airport. During the past two years, we have all witnessed the lack of communication and sense of common purpose between the city, private investors and the Port of St. Helens. While nearly every community in the nation is doing everything in its power to attract new investment and new family wage jobs, the Port has demonstrated a persistent unwillingness to act as a full partner. The Port's decision to bring a lawsuit against the City of Scappoose for the adoption of a new land use zone, even though the new ordinance provides complete protection for the Port, is indicative of the constant strain between the Port and those who are working diligently to help the community's economy grow. The concerns of the businesses at the airpark is that the Port's negative actions regarding the airport are becoming

widely known. They are scaring away business. The businesses grow as the airport grows, but the airport is not growing. At the same time, the Aurora Airport has greatly increased its job base, with new businesses around it. Mike personally knows of several companies, Vans Aircraft, Pacific Coast Avionics and an aircraft restoration center, that wanted to move to Scappoose, but established operations at Aurora instead because they could not "get to first base" with the Port of St. Helens. These are companies that would be in Scappoose now, if not for the Port's inability to get a deal done.

The Scappoose Airport Business Association, as well as others who would like to see the potential of the Scappoose airport fully developed, are in agreement that the airport would be better served under the management of the City of Scappoose. They would like to ask the voters within the Port District to approve the amendment of the Port District's southern boundary, which is now the Columbia County - Multnomah County line, to be changed to Church Road in Warren. It is their hope that this question could be placed before the Port District voters on the May 2009 election ballot. In order to meet the election time line, they have asked that the Scappoose City Council refer the measure for consideration to the voters. We can no longer afford to waste and squander economic opportunities due to the inattention and ineptitude of the Port of St. Helens.

Commissioner Hyde can understand the concern, however, he does not believe the county can remove the Port's ownership with the vote of the people, any more than removing Mike from Oregon Aero.

Mike explained that there are ways to accomplish this and is willing to share that information with the Board.

Ed Freeman, 9385 Locust, Tigard, OR, 97223: As a business owner, he supports Mike and other business owners request. They have tried to work with the Port, and while some things have been successful, others have hit a stone wall. This is something that the voters should be allowed to consider.

Judy Ingram, 51836 SE 6<sup>th</sup> St., Scappoose: She is a Scappoose Council member but not here representing the council. She is aware of the many concerns of the business owners at the airpark and the inability of the Port to manage it. She does not feel the Port owns this property, the people do as the tax payers that support the Port. The frustrations, the stale mates, not talking, has got to stop. She would encourage the Board to seriously consider the request made by Mike Dennis.

Philip Barlow, City of St. Helens Council Member. He first wanted to welcome Earl Fisher as a new Commissioner. About a year ago, he came to the Board on an economic development issue. The city of St. Helens held a meeting about a week ago and there was presence from about every city in the county. It went well and he encouraged the Board to attend these meetings.

# **HEARING: WITHDRAWAL OF KERRY & BOECK ROADS:**

This is the time set for the public hearing, "In the Matter of the Proposed Withdrawal of County Road Status from Kerry Road and Boeck Road".

Spencer explained that the Board initiated this process on November 25, 2009. Notice was sent out and one response was received, which is part of County Counsel's hearing file, marked Exhibit "1".

Lonny Welter, Transportation Planner, reviewed his report to the Board. This procedure is not an "abandonment" or "vacation" of the roads. This is a "withdrawal" and under this procedure, the road continues to exist as a road in public use. The only change would be in the county's responsibility for maintaining the road.

The hearing was opened for public testimony.

With no testimony coming before the Board, the hearing was closed for deliberation. After little discussion, Commissioner Fisher moved and Commissioner Bernhard seconded to tentatively approve the withdrawal of County Road Status from Kerry Road and Boeck Road and direct staff to prepare the final order. The motion carried unanimously.

Commissioner Bernhard read the consent agenda in full. With the removal of Item (D), Commissioner Hyde moved and Commissioner Fisher seconded to approve the consent agenda as follows:

The motion carried unanimously.

#### **PSC WITH COMMUNITY ACTION TEAM:**

After a brief review by Sarah, Commissioner Hyde moved and Commissioner Fisher seconded to approve the Personal Services Contract with Community Action Team for Flood Recovery Administrative Services. The motion carried unanimously.
