COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

June 10, 2009

The Columbia County Board of Commissioners met in scheduled session with Commissioner Rita Bernhard, Commissioner Anthony Hyde and Commissioner Earl Fisher, together with Spencer Parsons, Assistant County Counsel and Jan Greenhalgh, Board Secretary.

Commissioner Bernhard called the meeting to order and led the flag salute.

MINUTES:

Commissioner Hyde moved and Commissioner Fisher seconded to approve the minutes of the May 7, 2009 Budget meeting; May 26, 2009 Work Session, May 27, 2009 Board meeting; and June 3, 2009 Staff meeting. The motion carried unanimously.

VISITOR COMMENTS:

None.

HEARING: SUPPLEMENTAL COUNTY BUDGET FOR 2008-2009:

This hearing was originally set for June 3, 2009 but that Board meeting was canceled. Therefore, the hearing has been re-noticed for June 24, 2009 at or after 10:00 a.m.

HEARING: AMEND SECTION 942 OF THE AIRPORT INDUSTRIAL ZONE:

This is the time set for the public hearing, 'In the Matter of an Application to Amend Section 942 of the Columbia County Zoning Ordinance in the Airport Industrial Zone".

Spencer Parsons explained that the County received a letter from the Department of Aviation on March 31, 2008 stating that the County's current AI zone does not fully apply all elements of the Airport Planning Rule, OAR 660-013. Specifically absent from the ordinance is the inclusion of 4 outright uses as defined in OAR 660-013-0100 and therefore not consistent with state code. These changes will need to be done by Ordinance. If approved by the Board, it would be tentative until the ordinance is prepared. For the record, the Board declared no conflicts of interest. Spencer went over the applicable criteria for this application, then read the pre-hearing statement into the record as required by ORS 197.763. He entered County Counsel's file into the record, listed all contents and labeled it Exhibit "1".

Glen Higgins, Chief Planner, came before the Board to give the staff report and reviewed the changes to the code that will allow for 4 additional permitted uses. The Planning Commission held a hearing on this application on April 6, 2009 and, along with staff, recommends approval of the legislative amendment to Section 942 of the CCZO. No comments in opposition have been received.

The hearing was opened for public testimony.

With no testimony coming before the Board, the hearing was closed for deliberation.

After little discussion, Commissioner Hyde moved and Commissioner Fisher seconded to tentatively approve the application TA 09-02 to amend Section 942 of the Columbia County Zoning Ordinance in the Airport

Industrial Zone and directed staff to prepare the ordinance. The motion carried unanimously.

COMMISSIONER BERNHARD COMMENTS:

Commissioner Bernhard reported on the MHAC and LADPC meetings she attended yesterday. She will also be in Salem on Friday to attend the AOC Human Services meeting.

On Saturday she attended a grand opening of the new Equestrian Camp Sites at Camp Wilkerson. There was a very good turnout

She was in Tillamook on Thursday to attend the NOHA meeting. There are a number of different agencies, churches, etc. working to help those who will be denied housing vouchers due to lack of funding.

On Wednesday the Board was in Salem to attend the Board of Forestry meeting.

She wanted to remind everyone that on Saturday, there will be an event held at Trojan for foster kids to fish for free. Commissioner Hyde stated that Saturday was also a free fishing day throughout the State for everyone.

COMMISSIONER HYDE COMMENTS:

Commissioner Hyde attended the Board of Forestry meeting in Salem on Wednesday and reported on the concerns with the harvest management plan and the need to amend it. He felt this was a very successful meeting and very important to Columbia County and the State of Oregon.

On Monday he was in Salem for the AOC legislative meeting and met with some of our legislators to discuss various issues.

Yesterday he met with a group of stakeholders to talk about the possibilities of creating a county wide Economic Development Committee and hiring someone to staff it.

COMMISSIONER FISHER COMMENTS:

Commissioner Fisher also attended the Board of Forestry meeting on Wednesday. He noticed the importance of having a physical presence at these meetings and was impressed with the way the Board listened to those attending.

On Monday he was in Salem to attend the AOC legislative meeting. While there, he attended a Governor's meeting on contracting issues. Again, it's important to have a presence in Salem and help shape policy.

The Board receives newsletters from OSU Extension Service which lists different classes available on food preparation and storage. He encouraged those who want to learn to attend.

He attended a Chamber meeting in Clatskanie. It was good to see that there are some new businesses starting up in the area. The Sheriff was there to give a presentation.

There was a presentation on LNG at the Kiwanis meeting last night.

He wanted to mentioned that, as we look at our budget, people need to understand the mandates that are required by the State. It seems that local governments are given more to do but receiving less money to do it.

Commissioner Bernhard commented on the discussion held yesterday at the work session on diking districts levy certifications and that the Board and county staff are working on that.

There was also a presentation given yesterday on a proposed splash park in the Courthouse Plaza area. This group is working with the county and City of St. Helens on this project, which is partially funded by the Ford Foundation. Fundraisers will be held to help raise funds for this project.

COUNTYWIDE TRANSIT PLAN:

Janet Wright briefly reported on the presentation made yesterday by Kittleson on the Countywide Transit Plan. A meeting will be held tomorrow with city planning commissions to review the plan and submit comments.

Recessed the meeting at 10:40 a.m. and reconvened at 10:50 a.m. at the City of St. Helens Council Chambers. Present were Commissioner Bernhard, Commissioner Hyde, Commissioner Fisher and Sarah Hanson.

The Board met with city Police Chiefs, State Police representatives, Sheriff and Undersheriff to discuss the operations of the firing range, budget reductions, police coverage outside city limits, putting a response plan in action and the Deputy Medical Examiner.

Commissioner Hyde gave some background on the firing range and his conversations with the FBI and future plans of an indoor shooting facility. Currently, there is a need to have someone manage the range and Gerry Simmons name came up. The costs for operating and management of the range will have costs. Police Chief Steve Salle will check with his city council to see if his agency could manage the firing range.

Discussion was held on the responsibility of the Deputy Medical Examiner and possible shared costs. Commissioner Hyde will speak to the District Attorney about this. Although there will be a huge gap in law enforcement services come August 1, 2009, all police chiefs felt that their city councils would not agree to having their officers responding to calls outside the city limits.

Some discussion was held on the County's budget and resulting reductions in services.

With nothing further coming before the Board, the meeting was adjourned.
