MINUTES

March 2, 2011

The Columbia County Board of Commissioners met in scheduled session with Commissioner Earl Fisher and Commissioner Henry Heimuller, together with Sarah Hanson, County Counsel and Jan Greenhalgh, Board Secretary. Commissioner Hyde was not present.

Robin McIntyre, Assistant County Counsel, stated that the County entered into an agreement in 2009 with the City of Vernonia and the Vernonia School District to

Services under this agreement are no longer applicable and, as directed by the Board, Robin has prepared a letter to the City of Vernonia and the Vernonia School District, terminating the agreement. After review and discussion, Commissioner Heimuller moved and Commissioner Fisher seconded to approve the termination letter as presented. The motion carried unanimously.

He mentioned that Commissioner Hyde is in Washington DC this week for the NACo conference and will be spending time on the hill meeting with the Congressman and Senators on the Secure Rural Funding re-authorization.

Commissioner Fisher commented on the HVAC and sprinkler system upgrades going on in the courthouse. These upgrades are made possible through grant funding.

He also mentioned the Sheriff's Levy coming up in May. This is very important to guarantee law enforcement services in our community.
