# COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

## MINUTES

# March 9, 2011

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde, Commissioner Earl Fisher and Commissioner Henry Heimuller, together with Robin McIntyre, Assistant County Counsel and Jan Greenhalgh, Board Secretary.

Commissioner Hyde called the meeting to order and led the flag salute.

Last Friday, Commissioner Fisher attended an event at the Warren General Store, where the signage was unveiled for the Hwy 30 Safety Corridor. This is just one part of Highway 30 safety project.

On Monday, he met with the Decision Maker group. This group is made up of leadership positions around the county who are looking at ways we can all work together on shared services. One idea was to jointly look at purchasing fuel as a group. It was a very useful meeting.

He saw a report on a news channel this past week stating that if everyone of us were to buy \$65 in product made in the USA, it would make a huge difference on our economy.

While in Tillamook, he also attended the NWACT meeting. Most of the NWACT projects are coming to an end soon. There are other needed projects and discussion was held on sending a message to ODOT on prioritizing each counties projects. There was also a mention of the Hwy 30 safety corridor in Columbia County.

He spend some time with Stan Mendenhall last week to familiarize himself with the Juvenile program.

He also met with the VA Services Officer, Dan Garrison and Nancy Harwood on launching the volunteer program in the VA office at Community Action Team. Volunteers from RSVP would help with phones and other office duties at the CAT office to help with the work load.

Commissioner Heimuller was very proud to attend the Miss Rodeo Oregon Coronation held at the Spirit Mountain Casino last weekend. The Queen is from Vernonia, Oregon and will be representing Columbia County.

Tomorrow he will be joining up with the St. Helens School District representatives for a tour of the schools throughout the district.

Commissioner Fisher wanted to remind people about the Empty Bowls fundraising event this Friday, March 11<sup>th</sup> at the McBride School and encouraged everyone to attend.
