# COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

#### MINUTES

# March 30, 2011

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde, Commissioner Earl Fisher and Commissioner Henry Heimuller, together with Sarah Hanson, County Counsel and Jan Greenhalgh, Board Secretary.

Commissioner Hyde called the meeting to order and led the flag salute.

### MINUTES:

Commissioner Heimuller moved and Commissioner Fisher seconded to approve the minutes of the March 16, 2011 Board meeting and March 16, 2011 Staff meeting. The motion carried unanimously.

#### CONSENT AGENDA:

Commissioner Hyde read the consent agenda in full. Items (N) and (O) were pulled and carried over. With no other changes/additions, Commissioner Heimuller moved and Commissioner Fisher seconded to approve the consent agenda as follows:

### IGA WITH CITIES FOR SOLID WASTE DISPOSAL:

Todd Dugdale, LDS Director, came before the Board to address the Intergovernmental Agreement with the cities in Columbia County for Solid Waste Disposal. Todd wanted to emphasize the importance of this agreement, which identifies the role the cities will play in solid waste management and that all solid waste from their cities will be processed through the county transfer station. This is huge in guaranteeing the success of the Transfer Station. This agreement is historic in that most don't have this type of agreement. This is a countywide enterprise that makes our transfer station work and cooperatively manage solid waste in our county. Roy will be talking more about this in his presentation. The agreement has already been signed by all cities.

After discussion, Commissioner Fisher moved and Commissioner Heimuller seconded to approve the Intergovernmental Agreement with the cities of Clatskanie, Columbia City, Prescott, Rainier, St. Helens, Scappoose and Vernonia for Solid Waste Disposal. The motion carried unanimously.

# SOLID WASTE PROGRAM FOR 2012:

Roy Weedman, Solid Waste Coordinator, gave a power point presentation on the Solid Waste Program and reviewed what this program has accomplished in 2010. This includes the first rate adjustment since 1998; update of the Solid Waste Ordinance; renewed a 20 year agreement with the seven incorporated cities in the county; improved the recycling programs and programs for the collection of household hazardous waste; community events and outreach; and improvements to the Dump Stoppers program. Roy then briefly went over the plans for the Solid Waste Program for 2011.

Commissioner Hyde suggested that Roy look into the Title III funding for the Solid Waste Program for next year.

### USDA REQUEST TO RENEW WILDLIFE SERVICES PROGRAM:

Jennifer Cuellar, Finance Director, reviewed the request from USDA for funding the FY12 Wildlife Services Program. Commissioner Hyde felt that the Board should have discussions with Dave Hill regarding the trapper program prior to making a decision on funding this. To be addressed at the 2:00 pm staff meeting.
