## COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

#### MINUTES

# May 11, 2011

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde and Commissioner Earl Fisher, together with Robin McIntyre, Assistant County Counsel and Jan Greenhalgh, Board Secretary. Commissioner Heimuller was not present.

Commissioner Hyde called the meeting to order and led the flag salute.

### MINUTES:

Commissioner Fisher moved and Commissioner Hyde seconded to approve the minutes of the May 4, 2011 Staff meeting. The motion carried unanimously. The May 4, 2011 Board meeting minutes were carried over one week.

### VISITOR COMMENTS:

None.

### DELIBERATIONS: WAYDE ELLIOTT SITE DESIGN REVIEW:

This is the time set for deliberations "In the Matter of the Application of Wayde Elliott for a Site Design Review on Approximately 5 Acres Zoned Light Industrial (M-2) in the City of St. Helens Urban Growth Boundary to Construct New Storage Units and for Future Industrial Authorized Uses".

The Board held a public hearing on May 4, 2011 after which the hearing was closed and deliberations were carried over to today. At the close of the hearing, Commissioner Heimuller had questions on the timing and location of the sewer and the width of right-of-way. If the Board wants this information in the record, they will have to reopen the record and give the applicant 7 days for rebuttal. As Commissioner Heimuller was not present, the Board felt there was no reason to reopen the record.

Under deliberations, Commissioner Fisher had some concerns with the condition to put in a sidewalk and then 6 months later having to tear it out for sewer lines, the actual location of the sewer lines or even when that would happen. We now have an agreement that the stretch of sidewalk is to be put in by August, 2012. He would like to see that as a condition of approval and that the applicant post a bond to ensure the installation of the sidewalks by August 2012. Commissioner Hyde addressed the need for the sidewalks to be put in immediately. There is no bus stop planned for this area in the immediate future. Regarding the Dolan v City of Tigard, it has no bearing in this case. It appears that the City of St. Helens wants the sidewalks done immediately, so that the work is done when the property is annexed into the city. The developer has no issue with putting the sidewalks in but really didn't want to have to do it twice. He is not sure it would solve the developers dilemma by moving the date to 2012. He would agree with requiring a bond, but have the date set for either when the property is annexed in to the city or when city services are put in or both.

Commissioner Fisher would assume that if the sidewalk is required and the city tears it up later to put in the sewer/water lines, they would be responsible for the repairs. However, it is still unknown where those lines will be sited and even a chance it won't even effect the sidewalk.

Robin understands that it is difficult to bond when the date is uncertain. If it were tied to annexation which may not happen for years, it would be difficult to get the bond.

After discussion, Commissioner Fisher moved and Commissioner Hyde seconded to tentatively approve Wayde Elliott's Site Design Review application DR 11-07 with conditions as proposed in the Staff Report except for condition 13(a) which will read "the applicant shall enter into an agreement in a form approved by the County to construct sidewalk and related frontage improvements in accordance with the City of St. Helens Transportation Safety Plan 1997, by August 31, 2012 and shall secure a performance bond in the amount of not less than 125% of the estimated cost to perform the work as determined by the Columbia County Public Works Director and direct staff to prepare the final order. Under discussion, Commissioner Hyde suggested including the word "current" to the City of St. Helens Transportation Safety Plan. Commissioner Fisher agreed and with the vote taken, the motion carried unanimously.

#### COMMISSIONER FISHER COMMENTS;

Commissioner Fisher also commented on the meeting in Clatskanie to talk with the citizens about the options out there for public health services. He wanted to thank Mayor Pohl for getting the word out about the meeting and appreciated the hospitality.

On the topic of public health, he received several calls this morning saying there is a news article that states the Board has made the decision to transfer public health services to OHSU. He want's everyone to know that is incorrect. There has been no such decision. We continue to be in discussions with OHSU about that possibility, but again, no decisions have been made at this time. call the Board office. He noted that another meeting will be held at the Courthouse next Monday at 6:30 pm.

He attended a United Taxpayers meeting last Thursday and appreciated the opportunity to meet with this group to discuss public health.

There was a meeting last week with the sub-committee of the Decision Maker group looking at fuel costs for the various agencies in the county and how working together may save costs.

He mentioned that the Board will be attending the NACo WIR conference next week.
