COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

October 12, 2011

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde and Commissioner Henry Heimuller, together with Robin McIntyre, Assistant County Counsel, and Jan Greenhalgh, Board Secretary. Commissioner Fisher was not present.

Commissioner Hyde called the meeting to order and led the flag salute.

MINUTES:

Commissioner Heimuller moved and Commissioner Hyde seconded to approve the minutes of the October 5, 2011 Board meeting and October 5, 2011 Staff meeting. The motion carried unanimously.

VISITOR COMMENTS:

1ST READING OF ORDINANCE 2011-3: SCAPPOOSE UGB EXPANSION:

This is the time set for the first reading of Ordinance No. 2011-3, "In the Matter of an Application by the City of Scappoose (PA 11-01) for a Major Map Amendment to Change 378 Acres of Rural Residential, Rural Industrial, Agriculture Resource and Community Service to Urban Growth Boundary (UGB)".

The Board heard this matter at a public hearing in August and tentatively approved the application with conditions. With no objection, Robin gave the first reading of Ordinance No. 2011-3, by title only. Commissioner Heimuller moved and Commissioner Hyde seconded to set Wednesday, October 26, 2011 at or after 10:00 am for the second reading of this ordinance. The motion carried unanimously.

Commissioner Hyde read the consent agenda in full. With no changes/additions, Commissioner Heimuller moved and Commissioner Hyde seconded to approve the consent agenda as follows:

- (F) Energy Conservation Program Customer Implementation Agreement with Columbia River PUD for Non-Custom Projects at Existing Non-Residential Facilities and authorize the Chair to sign.

The motion carried unanimously.

Commissioner Hyde reported on his trip to Virginia where he spoke on our linear trail and other various topics on Columbia County.

Yesterday, he was in Sunriver attending an Oregon Emergency Management meeting. They met with the weather service on what to expect this winter and discussed the training center slated to come to Scappoose.

Next Wednesday he will be meeting with DeFazio on the Secure Rural Schools reauthorization and then will be headed to Bothell, Wa. for a FEMA Region 10 meeting.

Last Monday he was in Salem for an AOC meeting. They talked about the upcoming session, the budget, etc.
