# COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

#### MINUTES

October 26, 2011

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde and Commissioner Earl Fisher, together with Robin McIntyre, Assistant County Counsel, and Jan Greenhalgh, Board Secretary. Commissioner Heimuller was not present.

Commissioner Hyde called the meeting to order and led the flag salute.

#### MINUTES:

Commissioner Fisher moved and Commissioner Hyde seconded to approve the minutes of the October 19, 2011 Board meeting and October 19, 2011 Staff meeting. The motion carried unanimously.

# VISITOR COMMENTS:

Craig Smith, BCX, Inc., PO Box 1327, Rainier, Or: Craig presented the Board some additional information regarding the past due depletion fees for material taken from Dibblee Pointe. He had previously requested a waiver for a portion of those fees, but after consideration by the Board, that request was denied. Craig feels there may have been a misunderstanding and would like the Board to reconsider this request because a portion of these fees, considered past due, have actually been paid by Knife River. He explained that agreement BCX has with Knife River regarding the payment of depletion fees. Craig wants to get this resolved but doesn't believe they should be paid twice. The Board agreed to allow Craig time to submit additional information from Knife River for Board review and reconsideration.

Sherry Ford, Public Health, 2370 Gable Road, St. Helens: Sherry is here to give the Board an update on their federal grant remodel project for school based health centers. On the Sacagawea remodel, they are maximizing the use of space and adding another exam room for more privacy and confidentiality. They are in the process of finalizing the design with Lower Columbia Engineering and hope to release an RFP for the construction phase in early March. In Rainier, the superintendent is currently working on the permitting process to add another modular building, doubling the size of the Rainier school based health center. Sherry applauds the school district administrators for partnering with public health to make all this happen. Both clinics will be open and operating in the fall.

Commissioner Fisher wanted to congratulate Sherry on all the hard work she has put into this project to help make it all possible. These school based health centers are just wonderful things to have in our community and he just wishes they could be in every school. He also encouraged Sherry to promote this county wide.

# 2<sup>ND</sup> READING OF ORDINANCE 2011-3: SCAPPOOSE UGB EXPANSION:

This is the time set for the second reading of Ordinance #2011-3, "In the Matter of an Application by the City of Scappoose (PA 11-01) for a Major Map Amendment to Change 378 Acres of Rural Residential, Rural Industrial, Agriculture Resource and Community Service to Urban Growth Boundary (UGB)". With no objection, Robin gave the second reading of Ordinance No. 2011-3, by title only and noted that it is now ready for adoption.
