# COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

# MINUTES

December 14, 2011

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde, Commissioner Earl Fisher and Commissioner Henry Heimuller, together with Robin McIntyre, Assistant County Counsel, and Jan Greenhalgh, Board Secretary.

Commissioner Hyde called the meeting to order and led the flag salute.

## **MINUTES:**

Commissioner Heimuller moved and Commissioner Fisher seconded to approve the minutes of the December 7, 2011 Board meeting and December 7, 2011 Staff meeting. The motion carried unanimously.

## **VISITOR COMMENTS:**

*Tammy Maygra, 34319 Cannan Road, Deer Island:* Tammy was present to address her concerns about the Columbia Health District (CHD). She asked that the Board submit their resignations and, as a convenience, Tammy has drafted resignations for each of the Commissioners to sign.

# NATIONAL WEATHER SERVICE - STORM READY RECOGNITION:

Steve Todd, of the National Weather Service was present to recognize the county staff for their work on the Storm Ready program. The NWS is now designating Columbia County as storm ready. Steve presented the Board with a plaque and a Storm Ready sign. He stated that this award is not so easy to get and Columbia County is only the 8<sup>th</sup> county in

Oregon to receive it. He commends Columbia County for their work on this program.

The motion carried unanimously.

#### HUDSON GARBAGE SERVICE COMPLAINTS:

John Upton, 60407 Robinette Road, St. Helens: John received a notice last Tuesday from Hudson Garbage Service stating that, effective immediately, they will no longer be able to go up driveways to pick up garbage and people would have to place their cans at the end of the driveway. Now this wouldn't be such an issue if you live in town, but in the rural areas, driveways can be quite long. This will negatively effect a lot of people who can't physically do it. He was able to speak with the company and, after that discussion, he was told that he would no longer have to take his cans to the end of the road. Commissioner Heimuller stated that the Solid Waste Advisory Committee is meeting on January 17, 2012 and this issue is on their agenda. He suggested that anyone interested should attend.

*Jason Kirschman, Hudson Garbage, 4005 N Pioneer Drive, Richland, WA*: This change was put into effect as a safety issue, but the company is now looking at each property on a case by case basis. He apologized for it getting to this point and they are working on making it right.

Ken Strong, 3486 Achilles Road, Warren: He asked that, when the contracts were signed

for garbage service, why does the contract change just because they get bigger trucks? If the company has concerns about safety or damaging roads, they should stay with the smaller trucks. Until this is dealt with, he will have to cancel his service and self haul his garbage.

# COMMISSIONER HYDE COMMENTS:

Commissioner Hyde reported on the NACo Board meeting held last week in Orlando. There is a priority report on the NACo website.

On Monday, he attended the Oregon Business Summit where they discussed the economic plan for the next year.

He has been invited to meet with the Governor on Monday to talk and strategize on the reauthorization of the Secure Rural School Funding.

Vernonia resident MacKenzie Carr won the Miss Rodeo America title this month in Las Vegas. This is the first Miss Rodeo America from Oregon and we're very honored to see she was from Columbia County.

He gave a shout out to Jeff Scurvins from Napa who, in competing with loggers from around the world, he came in second place.

## COMMISSIONER FISHER COMMENTS;

Commissioner Fisher reported on the AOC meeting he attended in Portland on Monday dealing with health care issues.

He will be meeting with the school superintendents on Monday to discuss the building of a work force here in Columbia County. They are working to put together a curriculum to

help provide training and jobs in the county.

# COMMISSIONER HEIMULLER COMMENTS:

Commissioner Heimuller reminded everyone that this is the week for putting together the food and toy baskets for Kiwanis. Columbia County employees have made the difference this year and helped fill the gap.

He wanted to give a shout out for CC Rider for transporting over 80 residents from local nursing homes to see Christmas lights, Santa and enjoy some holiday treats.

The Sheriff made a report to the Board yesterday on how they are dealing with emergency calls and feels he has a very good program in place.

The Board recessed the meeting at 10:45 a.m. and reconvened at 11:00 a.m.
