MINUTES

April 4, 2012

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde, Commissioner Earl Fisher and Commissioner Henry Heimuller, together with Robin McIntyre, Assistant County Counsel and Jan Greenhalgh, Board Secretary.

Commissioner Hyde called the meeting to order and led the flag salute.

This is the time set for deliberations on proposed Ordinance No. 2012-1, "In the Matter of the Adoption of the Columbia County Rabies Vaccination Reporting Ordinance".

The Board is scheduled to meet with all Veterinarians in the county on Monday, 4/16/12 to address any concerns they may have with this ordinance. As the outcome of this

meeting is uncertain, Commissioner Fisher moved and Commissioner Heimuller seconded to hold this matter over indefinitely. The motion carried unanimously.
