COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

May 9, 2012

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde, Commissioner Earl Fisher and Commissioner Henry Heimuller, together with Sarah Hanson, County Counsel and Jan Greenhalgh, Board Secretary.

Commissioner Hyde called the meeting to order and led the flag salute.

MINUTES:

Commissioner Heimuller moved and Commissioner Fisher seconded to approve the minutes of the May 2, 2012 Board meeting and May 2, 2012 Staff meeting. The motion carried unanimously.

VISITOR COMMENTS:

Richard Melton, 55141 Columbia River Hwy, Scappoose: Richard has noticed a lot of elections signs along the highway, on posts, in yards, etc. When he posted signs on his property, he was informed that because he did not have an electrical permit, the signs were removed. He cannot understand why he is being singled out and he is the only one in the county that needs an electrical permit to hang a sign.

PROCLAIM "EMERGENCY MEDICAL SERVICES WEEK":

Kevin Westfall, CC Rider, was present at the request of Metro West to help promote "Emergency Medical Services Week" and referred to the proclamation now before the Board. With that, Commissioner Hyde read the document in full, after which Commissioner Heimuller moved and Commissioner Fisher seconded to proclaim May 20-26, 2012 as "Emergency Medical Services Week". The motion carried unanimously. Kevin also wanted to invite the Board to Metro West's Annual BBQ on May 25th, 3:30 pm at the Metro West location in Hillsboro.

- (D) Addendum #1 to the Personal Services Contract with David Evans and Associates for Northwest Oregon Transit Alliance Regional Transit Project and authorize the Chair to sign.

CC RIDER FACILITY UPDATE:

Janet gave the Board an update on the official grand opening of the new CC Rider facility. The flex funding has been awarded by the State to complete the facility however those funds won't be released until the agreement is approve. Janet is still waiting for that agreement from the State. Because the contractor has indicated that it will take about 3 months to complete the project, those funds need to be received by June in order to meet the October deadline.

COMMISSIONER HYDE COMMENTS:

Commissioner Hyde attended the last official Oregon Solutions meeting yesterday on the Vernonia Schools project. They will be opening on August 23rd just prior to the beginning of the school year. He toured the site yesterday and it's amazing on what's been done in such a short amount of time, with funds that didn't even exist when the project started. Hats off to the Oregon Solutions process, which has had nothing but success.

Tomorrow afternoon and all day Friday, the Oregon Business Development Commission will be here holding their meeting here in Columbia County at Pacific Stainless. It's a public meeting and open to the public.

COMMISSIONER FISHER COMMENTS:

Commissioner Fisher had the opportunity to tour the Vernonia Schools. He was very impressed with the work done out there. Many hands were involved in this project,

including Columbia County. This project was also discussed last night at Regional ESD meeting, who is looking forward to holding some of their meetings out there.

Commissioner Fisher has received some calls regarding the recent article on CCO's. This continues to be a moving project. GOBHI has now filed for that status and should hear by the end of June if that application has be accepted. This is a structural change in the operations of health care throughout Oregon. If done right, it could save the State \$10 billion.

Yesterday, he had the opportunity to speak on the topic of government to the students at the St. Helens High School. He was impressed with their interest.

COMMISSIONER HEIMULLER COMMENTS:

Commissioner Heimuller will be attending a NOHA meeting tomorrow in Warrenton, followed by the NWACT meeting.

On Friday he will participating in a conference call with the Oregon Fair's Commission while heading to Salem for an AOC Human Services Committee meeting.

On a personal note, Commissioner Heimuller was proud to announce that his daughter is being crowned the Columbia County Dairy Princess at Sauvie Island grange on Saturday at 7:00 pm. He extended an invitation to the Board and staff.
