CONSENT AGENDA:

Commissioner Hyde read the consent agenda in full. With no changes/additions, Commissioner Heimuller moved and Commissioner Fisher seconded to approve the consent agenda as follows:

- (E) Juvenile Accountability Block Grant 2011-6341 Award, Conditions and Certifications CFDA #16.523 and authorize the Chair to sign.
- (F) Approve the Oregon Infrastructure Finance Authority Project Notification and Intake Form for emergency road repair and debris removal and authorize the Chair to sign.

COMMISSIONER HYDE COMMENTS:

Commissioner Hyde married off his daughter last week in Sisters, Oregon.

On Monday he was in Salem participating in a meeting with ARFC, as an AOC and O&C Board member. This group is working with the private timber industry to find a resolution for the management of our forests. He believes this is moving in a good direction.

Yesterday he attended the CEPA meeting and then the ribbon cutting for Fultano's, the new pizza restaurant in Scappoose. It's good to see the growth in our county with new businesses coming in.

He continues to work with PCC and their consultants to look at the potential curriculum for their site in Scappoose. PCC continues to be committed to site an actual campus in Columbia County.

COMMISSIONER FISHER COMMENTS:

Regarding our forests, he read an article this morning that there is a big concern with our atmosphere because of the release of methane gas from the diseased trees in our forests. These trees are diseased because the very people that are worrying about this, won't allow the trees to be cut out. Many of the rules that have been put in place over the past 20 years to supposedly protect our forests are not working because they didn't use common sense. He finds it ridiculous that over 7000 acres of federally managed land burns because of our management practices.

Work is continuing with the Hwy 30 Safety Committee and mentioned that the subcommittee on education will be asking our local governments to proclaim September as Traffic Safety Month. There will be a proclamation prepared for consideration by the Board next week.

He also attended the CEPA meeting and the grand opening of Fultano's.

He enjoyed the parade last weekend at the Vernonia Jamboree. It shows the vitality of a community coming back to life after some devastating events.

COMMISSIONER HEIMULLER COMMENTS:

Commissioner Heimuller missed the Vernonia Jamboree but had the pleasure of attending the Umatilla County Fair and visited with their Commissioners. It was a good time.
