COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

November 21, 2012

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde and Commissioner Henry Heimuller, together with Robin McIntyre, Assistant County Counsel and Jan Greenhalgh, Board Office Administrator. Commissioner Fisher was not present.

Commissioner Hyde called the meeting to order and led the flag salute.

MINUTES:

Commissioner Heimuller moved and Commissioner Hyde seconded to approve the minutes of the November 7, 2012 Board meeting and November 7, 2012 Staff meeting. The motion carried unanimously.

VISITOR COMMENTS:

Richard Melton, 55141 Columbia River Hwy, Scappoose: He has continued to complain to the Board about the lights on his property that were ordered down by the County. He has talked with CRPUD and they, along with the State, has suggested that he come back to the County to ask the Board for the specific electrical code he was in violation of and, if they cannot provide that, the county sued for harassment of the disabled and handicapped. State will also file criminal charges against the County.

Don Campbell, 75735 Price Road, Rainier. Don came before the Board to ask the question as to why a non-conforming use is being allowed to continue on the north

system of the septic system of the Deer Pointe MHP. He is requesting an answer to this question in writing.

CONSENT AGENDA:

Commissioner Hyde read the consent agenda in full. With no changes/additions, Commissioner Heimuller moved and Commissioner Hyde seconded to approve the consent agenda as follows:

- (G) Amendment #14 to the 2011-13 IGA #134305 with DHS and authorize the Chair to sign.

He commented on the RVSP lunch meeting today at Sunchine Pizza and it's open to the

public.

The Fair Board continues to hold their meetings and are currently in negotiations with the

Warren Grange who is willing to upgrade the 4-H building at their expense. This is not

finalized yet, but going through the Fair Board approval process.

Commissioner Hyde briefly commented on the recent weather event and, although no

serious issues, it did allow the emergency service responders to dust off their procedures.

With nothing further coming before the Board, the meeting was adjourned.
