# COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

#### **MINUTES**

## December 19, 2012

The Columbia County Board of Commissioners met in scheduled session with Commissioner Earl Fisher and Commissioner Henry Heimuller, together with Robin McIntyre, Assistant County Counsel and Jan Greenhalgh, Board Office Administrator. Commissioner Hyde was not present.

Commissioner Fisher called the meeting to order and led the flag salute.

## **MINUTES:**

Commissioner Heimuller moved and Commissioner Fisher seconded to approve the minutes of the December 12, 2012 Board meeting and December 12, 2012 Staff meeting. The motion carried unanimously.

#### FUNDING REQUEST: MICRO ENTERPRISE SERVICES OF OREGON:

Sanford Maddox, Micro Enterprise Services of Oregon (MESO), 40008 NE Martin Luther King Blvd., Portland, OR 97212. Mr. Maddox gave a brief history on MESO, which is a non-profit company who takes a hands-on approach to deliver training, technical and capital assistance to small businesses. MESO has provided loan and IDA opportunities for clients, not only in St. Helens, but in Rainier, Vernonia, Scappoose and Clatskanie. With everyone involved working together, this program has been very successful. They

received a grant in 2011 from USDA for \$19,100, however that funding ended in September. MESO has been working with a number of small businesses in Columbia County to help them be successful, they have helped created 1 job and retain 8 others by training and marketing. Sanford is here today to request funding to allow MESO to continue to assist small businesses in Columbia County.

After discussion, Commissioner Heimuller moved and Commissioner Fisher seconded to authorize the expenditure of \$5,000 to the Micro Enterprise Services of Oregon (MESO) project. The motion carried unanimously.

The Board also agreed to prepare a letter of support for Micro Enterprise Services to secure funding.
