# COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

#### **MINUTES**

May 22, 2013

The Columbia County Board of Commissioners met in scheduled session with Commissioner Henry Heimuller and Commissioner Earl Fisher, together with Robin McIntyre, Assistance County Counsel and Jan Greenhalgh, Board Office Administrator. Commissioner Hyde was attending a NACo conference in Arizona.

Commissioner Heimuller called the meeting to order and led the flag salute.

## 2<sup>nd</sup> READING OF ORDINANCE 2013-1 - AMEND SOLID WASTE ORDINANCE:

With that, Commissioner Fisher moved and Commissioner Heimuller seconded to adopt Ordinance No. 2013-1, "In the Matter of Amending the Columbia County Solid Waste Management Ordinance to Further

Define Waste Disposal, Transport, and Storage Activities that are Exempt from the Franchise Requirement". The motion carried unanimously.
