COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

July 24, 2013

The Columbia County Board of Commissioners met in scheduled session with Commissioner Henry Heimuller, Commissioner Anthony Hyde and Commissioner Earl Fisher, together with Robin McIntyre, Assistant County Counsel and Jan Greenhalgh, Board Office Administrator.

Commissioner Heimuller called the meeting to order and led the flag salute.

MINUTES:

Commissioner Hyde moved and Commissioner Fisher seconded to approve the minutes of the July 10, 2013 Board meeting and July 10, 2013 Staff meeting. The motion carried unanimously.

VISITOR COMMENTS:

Jim Huffman, Scappoose: As an attorney, he spends a lot of time at the courthouse and wanted to address his concerns with the recent change to access between the two courthouse buildings. This has caused some problems for attorneys and clients who don't have that access.

Secondly, the lip on the handicap ramp recently installed in front of the Courthouse Annex is too high. He's surprised that was allowed. Commissioner Heimuller stated that this is news to the Board and will ask Todd Dugdale to check into that. Commissioner Heimuller stated that the old Courthouse has never been ADA accessible and asked Jim if he would have any suggestions. Jim understands that the building is not ADA accessible, but it is still less cumbersome for someone with disabilities to take an elevator up so only having to get up one flight of stairs instead of two. The issue is the doors are now locked between the buildings. Commissioner Heimuller stated that he would look into this.

COMMISSIONER HYDE COMMENTS:

Commissioner Hyde just returned after 5 days in Fort Worth, Texas for the annual NACo conference. One of the most important accomplishments were that the resolutions from O&C were ratified and we now have NACO's full weight of lobbying force working on those issues.

He reported on the new FEMA insurance costs which have increased to the tune of around \$4,000 plus per year - an astronomical increase. People will end up having to walk away from there homes and foreclosures will skyrocket. This is a the most serious and important issue facing the nation.

He reported that Tillamook County Tim Josi did not win the election for NACo President but did win the seat for the northwest region.

COMMISSIONER FISHER COMMENTS:

Commissioner Fisher expressed his thanks to all of the Fair volunteers who put so much effort into another successful Fair.

He attending a meeting with ESD who will be putting in their application to be our ELC hub. The timing to get the Request for Application is coming soon. If approved, they will be 1 of 7 hubs in the State.

Tonight, ODOT will holding one of their last Hwy 30 safety meetings and will be presenting a draft of their proposals. The meeting will be held at 6:00 pm at the CRPUD building.
