COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING MINUTES

August 6, 2014

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde and Commissioner Henry Heimuller, together with Sarah Hanson, County Counsel and Jan Greenhalgh, Board Office Administrator. Commissioner Fisher was not present.

Commissioner Hyde called the meeting to order and led the flag salute.

MINUTES:

Commissioner Heimuller moved and Commissioner Hyde seconded to approve the minutes of the July 30, 2014 Board meeting and July 30, 2014 Staff meeting. The motion carried unanimously.

VISITORS:

Danner Christensen, 35234 Hazel Street, St. Helens: He his here once again to address the concerns of Envision Columbia County. The members of the public want to thank the Board for their stewardship in writing a letter to Global requesting information on their limits of their financial responsibility, along with their safety policies and procedures for the facility at Port Westward. Regarding the most important question of all, Global offered a response about their liability insurance for human injury and environmental/property damage potentially resulting from their operations at Port Westward, but they do not release such information to the public. Because of that, Danner would ask that the Board continue that stewardship to require that Global provide specific information regarding its liability coverage. He went on to suggest that those running for elected office return any campaign contributions to Global and not accept any

future donations. Danner will also be sending a letter to Wayne Mayo with the same request.

He reported on the immediate work being done through the House and Senate on a bill that would work for all.
