COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

January 5, 2015

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde, Commissioner Henry Heimuller and Commissioner Earl Fisher, together with Sarah Hanson, County Counsel and Jan Greenhalgh, Board Office Administrator.

Commissioner Hyde called the meeting to order and led the flag salute.

MINUTES:

Commissioner Heimuller moved and Commissioner Fisher seconded to approve the minutes of the December 31, 2014 Board meeting. The motion carried unanimously.

VISITOR COMMENTS:

None.

SELECT CHAIR/VICE CHAIR/BUDGET OFFICER/SET MEETING DATES FOR 2015:

- Commissioner Fisher moved and Commissioner Hyde seconded to appoint Commissioner <u>Heimuller as Chair of the Board for 2015.</u> The motion carried unanimously.
- Commissioner Fisher moved and Commissioner Heimuller seconded to appoint Commissioner Hyde as Vice Chair of the Board for 2015. The motion carried unanimously.

- Commissioner Heimuller moved and Commissioner Hyde seconded to appoint Commissioner Fisher as the County Budget Officer for 2015. The motion carried unanimously.
- Commissioner Fisher moved and Commissioner Heimuller seconded to continue with the current meeting schedule by holding the <u>Board meeting every Wednesday</u> <u>at 10:00 a.m.</u> and the <u>Staff meeting every Wednesday at 1:00 p.m. for 2015.</u> The motion carried unanimously.

It was noted that, if an issue arises that effects a specific community, the Board has the option to change the time and location of the Board meeting.

2nd READING OF ORDINANCE 2014-7: REPEALING NOS 90-18; 90-9;89-3:

This is the time set for the second reading of Ordinance No. 2014-7. With no objection, Sarah gave the seconded reading, by title only. With that, Commissioner Fisher moved and Commissioner Heimuller seconded to adopt Ordinance No. 2014-7, "In the Matter of Repealing Ordinance Nos. 90-18, 90-9 and 89-3 and Rescinding Related Orders". The motion carried unanimously.

2nd READING OF ORDINANCE 2014-8: REPEALING ORDINANCE NO. 92-1:

This is the time set for the second reading of Ordinance No. 2014-8. With no objection, Sarah gave the seconded reading, by title only. With that, Commissioner Fisher moved and Commissioner Heimuller seconded to adopt Ordinance No. 2014-8, "In the Matter of Repealing Ordinance No. 92-1". The motion carried unanimously.

2nd READING OF ORDINANCE 2014-9: REPEALING ORDINANCE NO. 78-2:

This is the time set for the second reading of Ordinance No. 2014-9. With no objection, Sarah gave the second reading, by title only. With that, Commissioner Fisher moved and Commissioner Heimuller seconded to adopt Ordinance No. 2014-9, "In the Matter of Repealing Ordinance No. 78-2". The motion carried unanimously. Although there were a lot of year end meetings, events, etc., he was able to take a couple of weeks off during the holiday season to spend with his family.

On Wednesday, he will be attending the Connect Oregon final review committee meeting to discuss an additional \$4.2 million that needs to be allocated. Then on Thursday he will be in Eugene for an O&C meeting and Monday will be in Salem for the opening of this years legislative session.

He wanted to mention that the new PGE plant at Port Westward is now fully online and operational. It came in ahead of schedule and under budget. This is good news for Columbia County because it starts the Department of Revenue clock ticking.
