MINUTES

June 17, 2015

The Columbia County Board of Commissioners met in scheduled session with Commissioner Henry Heimuller, Commissioner Anthony Hyde and Commissioner Earl Fisher, together with Sarah Hanson, County Counsel and Jan Greenhalgh, Board Office Administrator.

Commissioner Heimuller called the meeting to order and led the flag salute.

MINUTES:

Commissioner Hyde moved and Commissioner Fisher seconded to approve the minutes of the June 10, 2015 Board meeting; June 10, 2015 Staff meeting; June 10, 2015 Budget Hearing; and June 11, 2015 Budget Hearing. The motion carried unanimously.

CONSENT AGENDA:

Commissioner Heimuller read the consent agenda in full. With no changes/additions, Commissioner Fisher moved and Commissioner Hyde seconded to approve the consent agenda as follows:

AGREEMENT #15423 WITH DEPT OF JUSTICE FOR CHILD SUPPORT SERVICES:

Steve Atchison, District Attorney, came before the Board to request approval of the agreement with the Oregon Department of Justice for Child Support Services, to become effective 7/1/15. This agreement is in the best interest of the County and allows the County to keep our Child Support staff. Steve briefly explained how the child support system operates and the work that goes into the collection of the money owed to families in our community. County Counsel reviewed and would recommend approval. With that, Commissioner Hyde moved and Commissioner Fisher seconded to approve Agreement #15423 with the Oregon Department of Justice for Child Support Services. The motion carried unanimously.

COMMISSIONER HEIMULLER COMMENTS:

Commissioner Heimuller attended his second Columbia Pacific Coordinated Care
Organization meeting this week. They are almost through the strategic planning part
of this process and, once this program is up and running, it will be a great system.

He attended perhaps one of the last budget meetings for The Oregon Consortium last week. With the new Workforce areas, the TOC is winding down and that program should be closed out by the first of the next year.

He attended the Public Health Foundation meeting yesterday. They're doing great work over there and the Board will be hearing from the Public Health Administrator

He attended the RSVP Advisory Council meeting yesterday afternoon. The big topic of discussion right now is the My Fair Lady pageant to be held at the upcoming County Fair. All 5 senior centers will be represented.

This Saturday at noon is the St. Helens Kiwanis Club Parade. The Grand Marshall's will be a group made up of those who are celebrating 100 years of services, i.e. the Warren Grange, Columbia County Fair and Rodeo, Kiwanis International, and the St. Helens City Library.

Coffee with the Commissioners will be held this Friday in Clatskanie at Humps
Restaurant at 9:00 am. This is an opportunity for people to informally meet with the
Commissioners, have a cup of coffee and talk about whatever's in their mind.

COMMISSIONER HYDE COMMENTS:

Commissioner Hyde, as President of the Association of O&C, has been working hard on the management of federal lands in Oregon. He gave some background on this program and what the O&C funding means to Oregon counties.

On Monday, he went on a tour of Columbia County for the "Buy Local" campaign, traveling around the county to meet with local businesses. It was a very interesting and informative day.

Commissioner Fisher attended the Citizen Transit Advisory Committee meeting

That's a very dangerous time because some bills that have been killed, due to some hard work, can be resurrected. We need to keep a vigilant eye on this. The Drivers Education program is having problems recruiting teachers for this program. Anyone interested in becoming a teacher can contact the Board office for information. It is a paid position but will require training. There was no Executive Session held. With nothing further coming before the Board, the meeting was adjourned.
