He got a chance to speak with the Chief Judge of the Supreme Court Justice. He was able to listen to a lot of discussion on regulations that effect our counties. It was a very beneficial event.

On Saturday, the IOEF Hall has been revamped. The people of the community supported saving the building and raised over \$3 million to remodel it.

He attended the Traffic Safety Committee meeting this morning. Transportation dollars are just not available because the clean fuel bill trumped the transportation bill. He understands that we need to be concerned with the future issues, but we also need to take care of our current infrastructure issues, such as transportation.

He reminded everyone that school just started again and we all need to be aware of the children out and about. Please be careful out there.
