MINUTES

October 21, 2015

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde and Commissioner Earl Fisher, together with Sarah Hanson, County Counsel and Jan Greenhalgh, Board Office Administrator. Commissioner Heimuller was not present.

Commissioner Hyde called the meeting to order and led the flag salute.

MINUTES:

Commissioner Fisher moved and Commissioner Hyde seconded to approve the minutes of the October 14, 2015 Board meeting and October 14, 2015 Staff meeting. The motion carried unanimously.

VISITOR COMMENTS:

***Rosemary Lohrke, 56671 Mollenhour Road, Scappoose:*** Rosemary asked at what point is the Board with regards to the marijuana ordinance - where that stands. Sarah explained that the Marijuana Ordinance was heard by the Planning Commission who, on 10/12/15 made a recommendation to the Board to approve it. That will come before the Board on November 4, 2015 under a public hearing. Rosemary heard a speaker at a recent meeting, who is an attorney from Colorado and he explained how they handled the legalization of marijuana. He suggested there be a group that continually looks at the ordinance, rules, etc. because there are going to be a lot unanticipated situations that will come up over time. The group could consist of members from law

enforcement, growers, and those from the community who would have valuable input. The Board agreed that this ordinance will be a changing document as new issues arise and thanked Rosemary for her comments and suggestions.

- (E) Ratify the Application for Risk Management Incentive Grant Funds in the amount of \$7500 for Security Cameras and Authorize Sarah Hanson to sign.

- (F) Amendment #1 to IGA #148004 between Columbia County, Oregon Health Authority and Public Health Foundation of Columbia County and authorize the Chair to sign.
- (G) Amendment to Major Account Services-Master Services Agreement with ADP for Affordable Care Act Reporting and Authorize the Chair to sign.
- (H) Letter of Agreement extending Oregon Youth Authority Lease #3060 to November 30, 2015 and authorize the Chair to sign.
