COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

January 5, 2016

The Columbia County Board of Commissioners met in scheduled session with Commissioner Henry Heimuller, Commissioner Anthony Hyde and Commissioner Earl Fisher, together with Sarah Hanson, County Counsel and Jan Greenhalgh, Board Office Administrator.

Commissioner Heimuller called the meeting to order and led the flag salute. He explained that this meeting was scheduled for yesterday, however the courthouse was closed due to inclement weather conditions.

MINUTES:

Commissioner Hyde moved and Commissioner Fisher seconded to approve the minutes of the December 23, 2015 Board meeting and December 23, 2015 Staff meeting. The motion carried unanimously.

VISITOR COMMENTS:

Sally Brandenfels, 32934 Pittsburg Road, St. Helens: She is here today to plead for mercy with regards to her family's items that remain on the Holly Farm property across from their home. There still remains hundreds of shipping boxes and other materials for their holly business. She went over the issues surrounding ownership of the property and the things she has been dealing with over the past few years, with the title company, banks, etc. Her plea is that she can be able to remove their things before the demolition takes place, which is scheduled for today. She truly appreciates the help that Commissioner Heimuller provided them during their wreath production business this year

and is now asking the Board for some additional time to move the containers and other personal property across the street.

Commissioner Fisher understands the hardship this family is going through, however there are some safety issues. Perhaps the demo crew can move some of the items over. Commissioner Hyde agrees but feels that would need some discussion with County Counsel. No decisions were made at this time.
