MINUTES

January 27, 2016

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde, Commissioner Henry Heimuller and Commissioner Earl Fisher, together with Sarah Hanson, County Counsel and Jan Greenhalgh, Board Office Administrator.

Commissioner Hyde called the meeting to order and led the flag salute.

MINUTES:

Commissioner Fisher moved and Commissioner Heimuller seconded to approve the minutes of the January 20, 2016 Board meeting and January 20, 2016 Staff meeting. The motion carried unanimously.

COUNTY AUDIT REPORT:

Matt Graves, with Pauly, Rogers Inc., came before the Board to give a report on the results of the FY2015 Columbia County Audit. He gave some details on how the audit is conducted and then touched on the impact of the PERS unfunded liability. He reported no reservations on the audit and that is basically a clean audit and no deficiencies to report. The Board thanked Matt Graves, Jennifer Cuellar and her staff for their work on another successful audit.

Commissioner Hyde read the consent agenda in full. With no changes, Commissioner Heimuller moved and Commissioner Fisher seconded to approve the consent agenda as follows:

Commissioner Heimuller attended the Oregon State Dairy Princess Ambassador Coronation in Salem on Saturday. Although our Columbia County princess was not selected for the State Dairy Princess, she represented Columbia County very well. Last Friday he participated in the interview process at Community Action Team for Jim Tierney's replacement who is retiring this year. On Monday, he attended the CAT Board meeting where they officially appointed Dan Brown as the new CAT Director to take over when Jim retires. Thanks to Jim for all of his years of service and congratulations to Dan Brown.

He will be attending the Columbia 911 meeting tomorrow and on Friday he will be in Salem for the Special Transportation Investment Program (STIP) selection process. This is a non-highway investment pool of approximately \$10 million for programs such as transit, bike, pedestrian, airport, etc.

He wanted to mention the situation currently taking place in Harney County. Yesterday he spoke with Pete Runnels, Harney County Commissioner. Yesterday it escalated to a situation that we all hoped wouldn't happen and a person was killed. We send our prayers to all those involved in both sides of this issue. People on both sides of this issue need to realize the costs involved and that people are having to move out of the county because of death threats. This has changed their entire community and they deserve our thoughts and prayers.
