COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

November 23, 2016

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde and Commissioner Henry Heimuller, together with Robin McIntyre, Assistant County Counsel and Jan Greenhalgh, Board Office Administrator. Commissioner Fisher was not present.

Commissioner Hyde called the meeting to order and led the flag salute.

MINUTES:

Commissioner Heimuller moved and Commissioner Hyde seconded to approve the minutes of the November 9, 2016 Board meeting and November 9, 2016 Staff meeting. The motion carried unanimously.

VISITOR COMMENTS:

Jim Huffman, 52924 Cliff Drive, Scappoose: He was surprised about the article he read about the CRPUD election and their decision not to seat someone who lives at Brown's Landing because they live in a boat house. Jim went to the County Clerks office to find a copy of the original formation of the CRPUD district boundaries with the meets and bounds. Apparently, they can't find the information and it will take some time to locate it. Because this is a matter of significant public interest, Jim is hoping that the Board of Commissioners could help out by directing staff to locate the original ordinance that adopted the boundaries. Commissioner Hyde noted that the Board just reviewed that in the past 30 days, so they are confident it's correct. Jim gave some background on the PUD from the 1980's forward, but the long and short is that those living in the boat houses are paying taxes to the levy for the CRPUD. The Assessor's office should have record of those taxes paid to the PUD. Commissioner Hyde stated that the PUD is who provided the meets and bounds back in the 1999 annexation. Additionally, the Board had sent a letter to the PUD noting that the boat houses were not included in the district and there was no response. Jim then suggested that those people in the boat houses should be due a refund of the taxes paid. The Board agreed that might be something to look into. Jim thanked the Board for their help and will check back with them at a later date.
