# COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

#### MINUTES

July 12, 2017

The Columbia County Board of Commissioners met in scheduled session with Commissioner Henry Heimuller, Commissioner Margaret Magruder and Commissioner Alex Tardif, together with Robin McIntyre, Assistant County Counsel and Jan Greenhalgh, Board Office Administrator.

Commissioner Heimuller called the meeting to order and led the flag salute.

# MINUTES:

Commissioner Tardif moved and Commissioner Magruder seconded to approve the minutes of June 28, 2017 Board meeting and June 28, 2017 Staff meeting. The motion carried unanimously.

# 2<sup>ND</sup> READING: ORDINANCE #2017-2 - ADOPT TRANSPORTATION SYSTEM PLAN:

This is the time set for the second reading of Ordinance No. 2017-2, "In the Matter of Adopting the Columbia County Transportation System Plan and Related Amendments to the Columbia County Comprehensive Plan, Zoning Code and Subdivision and Partitioning Ordinance". After a brief review of this Ordinance, Robin gave the second reading of Ordinance No. 2017-2, by title only. With that, Commissioner Magruder moved and Commissioner Heimuller seconded to adopt Ordinance No. 2017-2, "In the Matter of Adopting the Columbia County Transportation System Plan and Related Amendments to the Columbia County Comprehensive Plan, Zoning Code and Subdivision and Partitioning Ordinance". Commissioner Tardif abstained. The motion carried

# PUBLIC ROAD EVENT PERMITS:

Lonny Welter and Cherie Moylan, Road Department, were present to address the Public Road Event Permits on 1) Seattle to Portland Bicycle Ride; 2) Hood to Coast Relay; 3) Ralph Painter Memorial Run; and 4) Wings & Wheels Half Marathon Run. All documentation has been received and Cherie is recommending approval of all 4 events. Some discussion was held on the timelines for submittal of event permits. Cherie will be sending the Board a formal request to increase the deadline for submitting complete paperwork to 90 days, as opposed to 60 days. After discussion, Commissioner Magruder
