COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

March 28, 2018

The Columbia County Board of Commissioners met in scheduled session with Commissioner Margaret Magruder, Commissioner Henry Heimuller and Commissioner Alex Tardif, together with Sarah Hanson, County Counsel and Jacyn Normine, Board Office Specialist.

Commissioner Magruder called the meeting to order and led the flag salute.

MINUTES:

Commissioner Tardif moved and Commissioner Heimuller seconded to approve the minutes of the March 21, 2018 Board meeting and March 21, 2018 Work Session. The motion carried unanimously.

VISITOR COMMENTS:

Alta Lynch, PO Box 369, Scappoose: Alta attended a meeting last night where Senator Johnson and Representative Witt presented some legislative updates including changes to land use laws in forest and agriculture. During the Q & A, they were told that the County Commissioners were not listening to the people that came out in force to oppose the re-zone of Port Westward. Alta would like to point out that just because every person cannot attend a meeting, that does not mean that the squeaky wheel speaks for the whole county. Pro or con individuals do not speak for all.

Brian Pixley, Sheriff's Office PIO, came before the Board to present his weekly update. A search warrant was served last week, which led to taking Devon Lewis Shockley into custody for supplying marijuana and methamphetamine to minors. The Columbia County Jail has (4) open Deputy positions, (2) open Control Room Tech. positions with seven (7) applicants to start a job shadow phase in the Control Room. You do not need to be a deputy to be in this position, but this may be the most important position within the jail, monitoring cameras, opening and closing all doors, and being responsible for safety and keeping an eye on everything and everyone. A few weeks ago, the County Commissioners visited the jail, and asked that the jail update the progress that happens with inmates as they complete programs. Lt. Pixley gave a brief description of each program currently offered to inmates. Completions included 15 inmates being baptized, 5 inmates completed level 1 of 3 of the Pathway's program. Starting next month we hope to start our life lessons programs. Last week the Sheriff's office had 247 calls for service, 28 traffic stops which led to 6 arrests. Clatskanie had 62 calls for service, 11 traffic stops and made 3 arrests.

Jack Coe, Clatskanie High School - He is here today to job shadow with Commissioner Magruder. He is eager to learn.
