# COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

### MINUTES

May 30, 2018

The Columbia County Board of Commissioners met in scheduled session with Commissioner Margaret Magruder, Commissioner Henry Heimuller and Commissioner Alex Tardif, together with Sarah Hanson, County Counsel and Jacyn Normine, Board Office Specialist.

Commissioner Magruder called the meeting to order and led the flag salute.

### MINUTES:

Commissioner Tardif moved and Commissioner Heimuller seconded to approve the minutes of the May 16, 2018 Board meeting and May 16, 2018 Work Session. The motion carried unanimously.

### **VISITOR COMMENTS:**

**Brian Pixley, Sheriff's Office PIO,** came before the Board to present his weekly update. May 13-21, 2018, in that time the Sheriff's office had 265 calls for service, 28 traffic stops with 10 arrests. The Clatskanie District had 74 calls for service, 36 traffic stops with 1 arrest not all within the City Limits of Clatskanie.

Marine Patrol is gearing up to assist Multnomah Sheriff's office and the Coast Guard with Fleet Week that starts the week of June 5 -11. Our part is helping escort the Navy Ships down the Columbia River, once at the Seawall we help provide a security zone for other vessels traveling by.

This Friday we will be conducting a Jail Tour orientation for a group of people interested in volunteering for the Life Lesson pod of the jail. We are hoping for an early summer launch.

Introducing Deputy Adam Ralthke, Deputy Ralthke started with Columbia County Sheriff's office and Jail last year February 6<sup>th</sup> 2017. He transferred out to patrol in December 2017 and graduated from the Academy May 11<sup>th</sup> 2018. Deputy Rathke came to us straight out of the Marine Corps.

**Deputy Collin Brehm**, Columbia County Sheriff's Office gave briefing on multiple car break-ins on Pittsburg Rd. that took place on May 20<sup>th</sup> 2018. Items that were reported missing consisted of cash, cell phone charges, keys and guns. Deputy Brehm was able to track the break-ins and thefts back to a juvenile boy in Columbia County. The juvenile has been transported to Cowlitz County Juvenile Detention Center.

**Rachel Hagen 18446 Park Dr.** Clatskanie, Winner of the National American Legion Essay Contest, competing for National Jr. American Legion Auxiliary Member this year. Rachel read her award winning essay about being educated about America.

Rachel also shared her project over Memorial weekend called Boots and Shoes in Clatskanie. Rachel along with others placed boots and shoes filled with dirt and an American Flag with the name of Veteran or a family member along Hwy 30 in Clatskanie to honor our Veterans.

Commissioner Heimuller congratulated Rachel for all of her hard work.

Commissioner Magruder presented Rachel with a Columba County Challenge Coin and a small gift from Columbia County.

### LIFE SAVING AWARD PRESENTED TO DEPUTY COLLIN BREHM:

**Sheriff Dickerson**, here today to present Deputy Colin Brehm with the Life Saving Award. Collin Brehm on April 13<sup>th</sup> responded to a medical incident in the Clatskanie area, where an elderly woman was in cardiac arrest. Deputy Brehm first trained EMT on scene, with the assistance of the woman's husband performed CPR on scene, being able to get a pulse saving the woman's life.

Commissioner Heimuller recognized Sheriff Dickerson for his dedication to Columbia County and on behalf of the Board of Commissioners "Thank you". Sheriff Dickerson will retire June 4, 2018.

## MY FAIR LADY TEA:

The Board of Commissioners will recess at 11:00 a.m. to attend the My Fair Lady Tea at the Columbia County Shrine Club. My Fair Lady program has been going on for 30 years, this is part of our volunteer program. The third week of July one of our Fair Lady Princesses will be crowned My Fair Lady.

## HEARING: SUPPLEMENTAL BUDGET FOR FISCAL YEAR 2017-2018:

This is the time set for the public hearing, "In the Matter of Authorizing Supplemental Budget Appropriations, Contingency Transfers, Inter-Fund Transfers and Intra-Fund Transfers for Fiscal Year 2017-2018".

Jennifer Cuellar, Finance Director and Columbia County Treasurer, There was a Notice of Supplemental Budget Hearing so the members of the public have opportunity to weigh in on some changes that will be happening to the current year budget. Four funds triggered the need for a hearing because it was more than 10% of original budget needing to be updated. These funds are Parks, Fair Board Fund, Building Fund and Direct Pass Through fund for Grants.

Jennifer also spoke about the ERP project for the upcoming FY 2018-2019 and is very eager to move forward.
