COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

June 13, 2018

The Columbia County Board of Commissioners met in scheduled session with Commissioner Margaret Magruder, Commissioner Henry Heimuller and Commissioner Alex Tardif, together with Robin McIntyre, Assistant County Counsel and Jan Greenhalgh, Board Office Administrator.

Commissioner Magruder called the meeting to order and led the flag salute.

MINUTES:

Commissioner Tardif moved and Commissioner Heimuller seconded to approve the minutes of the June 6, 2018 Board meeting and June 6, 2018 Work Session. The motion carried unanimously.

VISITOR COMMENTS:

Brian Pixley, Sheriff's Office PIO, came before the Board to present his weekly report. Computer system was down so could not get accurate counts, but did have some approximates. CCSO 227 calls for service, 17 traffic stops, unsure if any arrests were made. Clatskanie PD received 65 calls for service, 10 traffic stops and at least 5 arrests. The Sheriff's office interviewed for lateral police officers and that went well and moving 1 person on for a background check.

Jail is starting a new program "Outside/Inside Connection", which allows family members from the outside to buy certain things for the inmates, i.e. birthday cupcakes, etc. This is

for inmates who have a negative balance on the commissary account. This seems to help with the overall attitude of the inmates. This is accessed through a website.

Brian is doing some research on starting a Threat Assessment Team. This team would help address issues of targeted violence, such as mass shootings, work place violence, school shootings, etc. The team would consist of law enforcement, community members, schools board members, CCMH and others.

There were 4 arrests in Clatskanie. Deputies were called out on an assault call. A couple of people broke the victims glasses and stole his phone. The next day, the victim came home to find his empty cell phone case on his porch, with a bullet sitting on top of it. That is a pretty serious threat, considering what just happened to him. After doing some investigation, 3 people were arrested. The fourth arrest was unrelated.

Commissioner Tardif asked about patrolling in Vernonia. Brian does not believe there is a routine patrol there, that's typically covered by the Clatskanie PD. The Sheriff wanted to get a resident Nehalem Valley deputy for that purpose, but that has just not yet come to fruition at this point in time.

Brian noted that he will not be here next week as he will be attending a military ceremony for his brother law.

CONSENT AGENDA:

Commissioner Magruder read the consent agenda in full. Commissioner Heimuller pulled Items (F) and (G) to obtain additional information. With no other changes/additions Commissioner Heimuller moved and Commissioner Tardif seconded to approve the consent agenda as follows:

- (G) C56-2018 Grant Agreement No. 32830 5339 with the Oregon Department of Transportation for the Purchase of Two Vehicles. (*Pulled and carried over*).

The motion carried unanimously.

COMMISSIONER TARDIF COMMENTS:

Commissioner Tardif was in Salem on Monday for AOC meeting. He then traveled to Tillamook for an AOC County College Alumni meeting. They took a tour of the new visitors center at the Tillamook Cheese Factory, which opens June 20th. On Tuesday, there was a tour of Stimson Lumber's 35,000 acre tree farm and learn about sustainable harvest practices. It was a very impressive operation. There was also a tour of the Oyster Farm in Netarts and the robotic cow milking.

There will be a second budget hearing on Thursday night at the County Courthouse, starting at 5:30 p.m.

She reminded all that the Kiwanis Parade is taking place this Saturday, starting at 12:00 noon.
