#### MINUTES

September 19, 2018

The Columbia County Board of Commissioners met in scheduled session with Commissioner Margaret Magruder, Commissioner Henry Heimuller and Commissioner Alex Tardif, together with Robin McIntyre, Assistant County Counsel and Jan Greenhalgh, Board Office Administrator.

## **COMMISSIONER TARDIF COMMENTS:**

Last week, Commissioner Tardif moderated the first town hall forum for education. The focus was on jobs and the economy in Columbia County. They had five presenters who did a phenomenal job with presenting the information and the facts about our county - where we started, where we're at, and where we're going.

The Tourism Steering Committee kickoff meeting was held last night. There were about 30 people in the room representing every nook and cranny of Columbia County.
