MINUTES

November 7, 2018

The Columbia County Board of Commissioners met in scheduled session with Commissioner Margaret Magruder, Commissioner Heimuller Heimuller and Commissioner Alex Tardif, together with Robin McIntyre, Assistant County Counsel and Jan Greenhalgh, Board Office Administrator.

Commissioner Magruder called the meeting to order and led the flag salute.

MINUTES:

Commissioner Tardif moved and Commissioner Magruder seconded to approve the minutes of the October 31, 2018 Board meeting and October 31, 2018 Work Session. The motion carried unanimously.

VISITOR COMMENTS:

AMENDMENT TO JUVENILE CRIME PREVENTION PLAN:

Janet Evans, Adult Corrections, and Seth Battles, CCMH, to discuss the Juvenile Crime Prevention Plan and some changes that need to be addressed. One of the programs, Teens & Family Transition, and contracting with CCMH for those services. CCMH has submitted a letter that CCMH is withdrawing for the contract because the grant funding has been reduced and it is costing more than the grant funding. This has been a very successful program. Seth has is own company, providing these services, and Janet would ask for approval to contract directly with Seth so there is no break in the program.

Seth talked about the program that he has worked since 1997. Again, this is a very successful program and he is very passionate about it. He would continue to meet clients at school, at their homes, the Juvenile department, or wherever it is best for the client. Janet briefly talked about the finance end of it.

Sarah has drafted a contract and ready for Board review. The Board can take the time to review and have it ready for the next meeting for approval.

COMMISSIONER HEIMULLER COMMENTS:

Commissioner Heimuller mentioned the Veterans Stand Down taking place this weekend at the Four Square Church.
