BOARD MEETING

MINUTES

February 20, 2019

The Columbia County Board of Commissioners met in scheduled session with Commissioner Henry Heimuller, Commissioner Margaret Magruder and Commissioner Alex Tardif, together with Tiffany Johnson, Assistant County Counsel and Jan Greenhalgh, Board office Administrator.

Commissioner Heimuller called the meeting to order and led the flag salute.

MINUTES

Commissioner Tardif moved and Commissioner Magruder seconded to approve the minutes of the February 13, 2019 Board meeting and February 13, 2019 Work Session. The motion carried unanimously.

VISITORS:

Sheryl Teuscher, PO Box 310, Rainier: She is promoting the Relay for Life, of which she has been a team member for the past 20 years here in Columbia County. There are citizens that are hit with cancer every day and are fighting the hard battle to survive. She is here today requesting County support to raise money and fight cancer. Her company, Country Financial, supports this cause annually. Last year 112 survivors came out to walk. Commissioner Heimuller suggested Sheryl contact Butch Guess, Fair Board Chair, who might know how to help out using the carnival contractor. CC Rider might also be available for transport.

1ST READING OF ORDINANCE #2019-4, SCOTT WINEGAR CCZO AMENDMENT:

This is the time set for the first reading of Ordinance No. 2019-4, "In the Matter of Application No. PA 18-01 and ZC 18-02 by Scott Winegar for Warren Community Fellowship to Amend the Comprehensive Plan Map and Zoning Map of 7.4 Acres to Relocate the Columbia County Christian School". With no objections, Tiffany gave the first reading of Ordinance No. 2019-4, by title only. The second reading will be scheduled for March 13, 2019, at or after 10:00 a.m.

The motion carried unanimously.

RESOLUTION NO. 5-2019, APPROVE PURCHASE OF BACKHOE:

A. Commissioner Heimuller noted that Resolution No. 5-2019 needs approval as part of the purchase of the backhoe for the Road Department. With that, Commissioner Magruder moved and Commissioner Tardif seconded to approve Resolution No. 5-2019, "In the Matter of Approving the Financing of a John

Deere Backhoe for the Public Works Department". The motion carried unanimously.

EMERGENCY REPAIRS TO GABLE ROAD:

Tristan Wood, Road Department, was present to address the emergency repairs needed to the culvert on Gable Road. They now have ODOT and DSL approval to move forward. A contract has been prepared with Kynsi Construction for the emergency repairs, along with Resolution No. 7-2019 approving the emergency repairs. County has reviewed both and they are ready for approval. After review and discussion, Commissioner Tardif moved and Commissioner Magruder seconded to approve Resolution No. 7-2019, "In the Matter of Authorizing an Emergency Procurement for the Replacement of a Culvert at Gable Road". The motion carried unanimously.

Further, Commissioner Tardif moved and Commissioner Magruder seconded to approve the Public Services Contract with Kynsi Construction for the emergency replacement of a culvert at Gable Road. The motion carried unanimously.

COMMISSIONER TARDIF COMMENTS:

Commissioner Tardif noted that the full Board will be in Washington, DC the first week of March to attend the NACo conference, which includes Capitol Hill visits.

COMMISSIONER MAGRUDER COMMENTS:

Commissioner Magruder attended the Rainier Chamber of Commerce annual meeting vesterday. The Grocery Outlet was awarded the business of the year because of all that owner, Taylor Elliott, does for the community. He is a great asset to our county.

COMMISSIONER HEIMULLER COMMENTS:
