BOARD MEETING

MINUTES

May 22, 2019

The Columbia County Board of Commissioners met in scheduled session with Commissioner Henry Heimuller, Commissioner Margaret Magruder and Commissioner Alex Tardif, together with Tiffany Johnson, Assistant County Counsel and Jan Greenhalgh, Board Office Administrator.

Commissioner Heimuller called the meeting to order and led the flag salute.

MINUTES

Commissioner Tardif moved and Commissioner Magruder seconded to approve the minutes of the May 15, 2019 Board meeting and May 15, 2019 Work Session. The motion carried unanimously.

VISITOR COMMENTS:

Rachel Krager and Christina Mendoza, Registered Nurses and Home Visiting Nurses with Columbia Health Services. Rachel shared information about their program and referred to her handout on their home visit nursing services. After some questions/answers, the Board thanked both for presenting this update.

Eva Frost, PO Box 422, Scappoose, and Al Peterson, 101 St. Helens St., St. Helens, came before the Board to give them an update on the Warren Grange Project at the Columbia County Fairgrounds, 4H Building. Eva noted that contributions for this project came from Knife River and a number of hours provided by Al Peterson. After review of the most current plans, Eva is looking for approval from the Board to continue moving forward with this project. After discussion, Commissioner Magruder moved and Commissioner Tardif seconded to approve the Warren Grange moving forward on the 4H Building improvement project. The motion carried unanimously.

TRANSFER OWNERSHIP OF K9 ODIN:

Sheriff Pixley was present to request approval to surplus retiring K9, Odin. Odin is the narcotics K9, is an adult male Shepherd and has been with the CCSO since 2015 when they got him from the Clatskanie Police Department. He is getting older now and too old for the position. The Sheriff would like to surplus Odin and transfer ownership of him to his previous handler Jacob Anderson. Sarah explained the process needed to approve this transfer. After review and discussion,

- Commissioner Magruder moved and Commissioner Tardif seconded to approve designating Odin as surplus and authorize the Chair to sign the paperwork. The motion carried unanimously.
- Further, Commissioner Tardif moved and Commissioner Magruder seconded to approve the contract between Columbia County and Jacob Anderson and authorize Sheriff Pixley to sign. The motion carried unanimously.

COMMISSIONER MAGRUDER COMMENTS:

Commissioner Magruder met with a 5th grader in Clatskanie who won the Columbia County spelling bee and will be representing Columbia County at the Oregon State Fair. Kudos to Kelby Evenson and good luck at State.
