

COLUMBIA COUNTY BOARD OF COMMISSIONERS

BOARD MEETING

MINUTES

October 16, 2019

The Columbia County Board of Commissioners met in scheduled session with Commissioner Henry Heimuller and Commissioner Margaret Magruder and Commissioner Alex Tardif, together with Tiffany Johnson, Assistant County Counsel and Jacyn Normine, Board Office Administrator.

Commissioner Heimuller called the meeting to order and led the flag salute.

MINUTES

Commissioner Magruder moved and Commissioner Heimuller seconded to approve the minutes of the October 9, 2019 Board meeting and October 9, 2019 Work Session. The motion carried. Commissioner Tardif abstained, he was not present for the 10.09.2019 Board or Work Session Meetings.

VISTIORS:

Kilynn Baker, 5988 Charming Way, St. Helens asking for clarification on how probation actually works. Commissioner Heimuller recommended that she talk to State Courts, Kilynn's overall questions are out of county jurisdiction.

MATTERS:

This is the time set for the First and Second Reading of Ordinance No. 2019-6 "In the Matter of Adopting Columbia County Livestock at Large Nuisance Ordinance".

Tiffany Johnson, Assistant County Counsel briefed the Board on the revised Ordinance No. 2019-6 adding lamas and alpacas.

Tiffany Johnson, read the first reading of Ordinance No. 2019-6 In the Matter of Adopting Columbia County Livestock at Large Nuisance Ordinance at 10:09 a.m.

Karen Schminke, Land Development Services Director, Issues that come from livestock at large is not limited to large hooved animals, but also poultry flocks and is recommending that poultry be added to the ordinance.

Public Testimony:

Laural Erickson, 22491 Lindberg Road, Clatskanie has issues with neighbor's pigs, and with no Ordinance that identifies that pigs are livestock, no legal action is able to be taken. This is an emergency. These pigs are causing thousands of dollars of damage to our property.

Kathi Mattinen 22493 Nelson Hill Lane, Clatskanie commented on Karen Schminke's comment about poultry, Kathi is asking that chickens be added to the ordinance. Kathi is also asking to include property damage under Health, Safety and Welfare. Kathi is asking that this ordinance be approved by emergency since it has been sitting on a desk for over a year.

Commissioner Heimuller addressed some of Kathi's comments, and explained that emergency ordinances, are not taken lightly, and not many of them are authorized by the Board, maybe one or two a year. He understands that his is emotional and maddening to the homeowners.

Steve Mattinen 22493 Nelson Hill Lane, Clatskanie is asking that something be done, this is pain and suffering.

Laural Erikson, just wants the pigs out of her yard- Please Help.

Commissioner Magruder, thinks that it might be wise to add poultry to the definition.

Commissioner Tardif, feels like a livestock ordinance is needed but that we need to have more time before signing this emergency ordinance. We need to give the community notice of this so they have time to come in and give their opinion.

Session went into recess when Counsel stepped out to clarify information.

Ordinance No. 2019-6 in the Matter of Adopting Columbia County Livestock at Large Nuisance Ordinance, Has been set over until October 30, 2019. Revisions to add poultry and rabbits to the definition.
