Exhibit A: She is moving the \$200,000.00 appropriation level from materials and services into capital purchase. This is for a software purchase that the Sheriff's office is doing in conjunction with the Jail. Exhibit B: is that there was capital gain purchases budget for \$10,000.00, this is for two metal detector units for Courthouse security the total price was \$22,000.00 we are moving the \$10,000.00 out of operating contingencies into capital outlay to complete the purchase.

Commissioner Tardif moved to approve Resolution 76-2019 In the Matter of a Supplemental Budget to Reallocate Appropriations between Budget Categories in the 2019-2020 Fiscal Year Budget (Public Health) Commissioner Heimuller seconded. The motion carried unanimously.
