DISCUSSION ITEMS:

1) ODOT-Improvements to US 30: Millard Rd. and Bennett Rd. Tony Snyder, ODOT Area Manager and Bill Jablonski, Transportation Project Manager presented a PowerPoint that updated the project with the county that began in December of 2010 when US 30 between Scappoose and St. Helens was designated a Safety Corridor. ODOT and Columbia County continued to move forward studying the section of highway in 2012. November of 2014 ODOT officially decommissioned the US 30 Safety Corridor designation due to a decrease in crash related accidents over time. ODOT concluded in 2015 their intent to add a signal at Millard Rd and remove the ability to make a left turn from Bennett Rd. onto US 30. Before ODOT begins bid process in fall, 2020 they need to enter into Inter-Governmental Agreement with Columbia County. Construction is planned for 2021.

County Counsel and Public Works have reviewed the agreement; Staff will forwarded that agreement to BOC for signatures later if you support the concept moving forward.

Yesterday she attended a meeting with the Association of Oregon Counties and The Oregon Fair Association to discuss potential funding for all the County Fairs in the State of Oregon and an ask to the legislature in the upcoming short session for additional funding for deferred maintenance and management to keep these very important fairs going.

Columbia County Fair is an all-volunteer run fair and we refer to as the living room of Columbia County. Many events take place at our fair grounds and it is a very important place.

COMMISSIONER TARDIF COMMENTS:

Monday he attended AOC in Salem where as an association they are lobbying very hard to restore the CCBHC funding for behavioral health services. A lot of movement in the criminal justice for behavioral health funding in the short legislative session to shore up some shortages that happened in the long session.

Other hot topics is the LC19 also known as Cap and Trade. It looks like the legislature is trying to push that through again, so as a citizen if you are 100% in favor or 100% against it is important that we are paying close attention and speak our voice and what would be best for our community.
