MINUTES

February 05, 2020

The Columbia County Board of Commissioners met in scheduled session with Commissioner Alex Tardif Commissioner Margaret Magruder, together with Sarah Hanson, County Counsel and Jacyn Normine, Board Office Administrator. Commissioner Henry Heimuller was not present.

Commissioner Tardif called the meeting to order and led the flag salute.

MINUTES

Commissioner Magruder moved and Commissioner Tardif seconded to approve the minutes of the January 29, 2020 Board meeting and January 29, 2020 Work Session. The motion carried unanimously.

VISITOR COMMENTS- 5 MINUTE LIMIT:

Sheriff Pixley, updated the Board on the search and rescue that took place in Columbia County. The search and rescue unfortunately ended in a body recovery. Sheriff Pixley thanked the community and Agencies that helped and supported efforts during the search.

January 2020 The Columbia County Sheriff's Department had 147 traffic stops and 1040 calls for service, Clatskanie P.D had 52 traffic stops and 255 calls for service.

HEARING:

Jail Levy: County Counsel, Sarah Hanson briefed the Board and introduced Sheriff Pixley. Sheriff Pixley present information on how the Jail Levy will work and why it is important to Columbia County.

The purpose of the Hearing is to provide information and take testimony regarding the County's plan to submit a Jail Levy renewal to the voters in May, 2020. The renewal of the Jail Levy will be at the same rate for 4 years.
