Commissioner Heimuller moved and Commissioner Magruder seconded to Ratify the letter dated 01.30.2020 accompanying records produced to the Spotlight News with the correction to remove the signature line signed not present for Commissioner Tardif. Motion passed 2-1.

Commissioner Tardif introduced HB 4014-A6, this bill will allow accessory dwelling units into Rural Residential zoning districts. The Board will have further discussion in the work session this afternoon.
