

**COLUMBIA COUNTY BOARD OF COMMISSIONERS  
BOARD MEETING  
MINUTES  
June 10, 2020**

The Columbia County Board of Commissioners met in scheduled session with Commissioner Alex Tardif, Commissioner Henry Heimuller and Commissioner Margaret Magruder together with Sarah Hanson, County Counsel and Jacyn Normine, Board Office Administrator via telecommunication with County Staff and public.

Commissioner Tardif called the meeting to order and led the flag salute.

**MINUTES**

Commissioner Heimuller moved and Commissioner Magruder seconded to approve the minutes of the June 3, 2020 Board meeting. The motion carried unanimously.

**VISITOR COMMENTS- 5 MINUTE LIMIT:** Don Campbell, Price Rd. Rainier OR. Following up from last week's conversation regarding the road work on Price Rd. Commissioner Heimuller said that Public Works has been working on the issue.

**PUBLIC HEALTH UPDATE:**

Mike Paul updated the results of COVID-19 with 7.2 million worldwide, 2 million cases in the US. Oregon has had an uptick in the last week. The State of Oregon had 70 new confirmed cases, 5 deaths, bring the state total to 4,988 confirmed cases and 169 deaths. Columbia County has 17 confirmed cases with 16 of those confirmed cases recovered. 29 of 36 Oregon counties have moved into Phase II, Multnomah County is getting ready to move into Phase I. With increased testing, Public Health Officials are expecting an increase number in confirmed cases.

Discussion was held regarding Columbia Health Services. No action was taken.
