# **COLUMBIA COUNTY BOARD OF COMMISSIONERS**

#### **BOARD MEETING**

#### **MINUTES**

### September 2, 2020

The Columbia County Board of Commissioners met in scheduled session with Commissioner Alex Tardif and Commissioner Margaret Magruder together with Robin McIntyre, Sr. Assistant County Counsel and Jacyn Normine, Board Office Administrator via telecommunication with County staff and members of the public. Commissioner Henry Heimuller was not present.

Commissioner Tardif called the meeting to order and led the flag salute.

#### MINUTES:

Commissioner Magruder moved and Commissioner Tardif seconded to approve the minutes of the August 26, 2020 Board meeting and August 26, 2020 Work Session. The motion carried unanimously.

<u>VISITOR COMMENTS- 5 MINUTE LIMIT:</u> Jolene Jonas, 28250 Hafferman Rd. Scappoose questioned where COVID-19 relief funds are being spent. Questioned the lease of the Olde School for housing Public Health. Commissioner Tardif will send her a spread sheet that shows where the monies are being distributed.

<u>PUBLIC HEALTH UPDATE:</u> Mike Paul, Public Health Director gave an update on the most current numbers of confirmed and presumptive cases, with 25 million globally and 851,000 thousand deaths, the US has reported over 6 million and over 183 thousand deaths, Oregon reported 26,946 thousand and 465 deaths. Columbia County has reported 129 confirmed and presumptive cases, 9 have been under hospitalization and one death since the onset of COVID-19.

Mike covered the 7 day report from OHA, school metrics, case count declines, tracing, workplace outbreaks around the state, death rates for 2020 being above average for the U.S., how CDC is reporting deaths, age groups that are at high risk.

**MATTERS:** No matters to come before this Board.

Commissioner Magruder referenced that from the onset of COVID-19 this Board has worked very diligently to protect the health and safety of our staff, our citizens and visitors to the County. She looked back to the beginning and recapped steps that took place in order to provide health and safety of all. These persuasions were put into place before we were aware there would be relief funding.
