BOARD MEETING

MINUTES

September 16, 2020

The Columbia County Board of Commissioners met in scheduled session with Commissioner Alex Tardif, Commissioner Henry Heimuller and Commissioner Margaret Magruder together with Sarah Hanson, County Counsel and Jacyn Normine, Board Office Administrator via telecommunication with County staff and members of the public was not present.

Commissioner Tardif called the meeting to order and led the flag salute.

MINUTES:

Commissioner Heimuller moved and Commissioner Magruder seconded to approve the minutes of the September 9, 2020. The motion carried unanimously.

VISTITOR COMMENTS:

Carroll Sweet, 52077 Rabinsky Rd. Scappoose, OR. and Annie Christenson, 35234 Hazel St. St. Helens, OR. joined the meeting today to discuss forming a Police Citizen Advisory Committee for the County and requested support from the Board. Commissioner Heimuller, Commissioner Magruder and Commissioner Tardif are in full support of forming a Police Citizen Advisory Committee.

PUBLIC HEALTH UPDATE: Mike Paul, Public Health Director gave an update on air quality in the Columbia County area, surrounding areas and we will be under an advisory through at least Thursday due to wildfires throughout the State of Oregon. Recommendations is to stay inside, keep doors and windows closed and drink plenty of water.

COVID -19 current numbers of confirmed and presumptive cases, with over 29.6 million globally and 936,313 thousand deaths, the US has reported over 6.6 million and over 196 thousand deaths, Oregon reported 29,662 cases and 519 deaths and Columbia County has reported 145 confirmed and presumptive cases, and one death since the onset of COVID-19.

Mike reported that we are starting to see an uptick in case numbers, he reviewed the 7 day case count report from OHA, CDC updated reports and which ethnic groups are being affected the most, which counties are in Phase I, Phase II and which counties are on the watch list. Yesterday, DCBC released a press release regarding a new program that will start this week that will help people who need to quarantine or isolate due to COVID-19 exposure and do not have access to COVID-19 related paid sick leave. Mike talked about Public Health staff and that funding is available through December 31, 2020 and Public Health is working with Columbia Health Services for wrap around services.

Discussion was held on funding for flu shots county wide.

Steve Pegram Emergency Management Director, reported that across the state the assessment of wildfire damage is going to be the largest in history, in the next week or so we will start seeing more accurate numbers of loss of life and property.

Columbia County is 1 of 26 counties that will receive funding for the wildfire relief fund.

Offered forth thoughts and prayers to all of the front line fire fighters, police officers, county commissioners, local volunteers and everyone involved in the wildfires across Oregon. The recovery of this is going to go on for years.

Special thanks to Columbia County volunteers and County employees for stepping forward to help our neighbors.
