## **BOARD MEETING**

#### MINUTES

#### September 23, 2020

The Columbia County Board of Commissioners met in scheduled session with Commissioner Alex Tardif, Commissioner Henry Heimuller and Commissioner Margaret Magruder together with Tiffany Johnson, Assistant County Counsel and Jacyn Normine, Board Office Administrator via telecommunication with County staff and members of the public was not present.

Commissioner Tardif called the meeting to order and led the flag salute.

#### **MINUTES:**

Commissioner Heimuller moved and Commissioner Magruder seconded to approve the minutes of the September 16, 2020. The motion carried unanimously.

**<u>VISTITOR COMMENTS</u>**: Scott Jorgensen, Rainier City Administrator joined the meeting for introduction as the new City Administrator. Discussion was held on what is happen in the City of Rainier.

**PUBLIC HEALTH UPDATE:** COVID -19 current numbers of confirmed and presumptive cases, with over 31 million globally and 972,568 thousand deaths, the US has reported over 6.9 million and over 200 thousand deaths, Oregon reported 31,313 cases and 532 deaths and Columbia County has reported 154 confirmed and presumptive cases, and one death since the onset of COVID-19.

Mike reported there are currently 40,000 cases per day in the US with a 13% increase over the last week. With smoke form the wildfires testing has been decreased. Discussion was held on case counts and increased case counts due to summer time activities such as Labor Day. Discussion was held on businesses requesting information from the customer and Public Health only receives the information when requested.

#### **COMMISSIONER TARDIF COMMENTS:**

We should be looking at Forest practices in Columbia County, looking at a program to educate against wildfires.
