BOARD MEETING

MINUTES

October 14, 2020

The Columbia County Board of Commissioners met in scheduled session with Commissioner Alex Tardif, Commissioner Margaret Magruder together with Sarah Hanson, County Counsel and Jacyn Normine, Board Office Administrator via telecommunication with County staff and members of the public. Commissioner Henry Heimuller was not present.

Commissioner Tardif called the meeting to order and led the flag salute.

MINUTES:

Commissioner Magruder moved and Commissioner Tardif seconded to approve the minutes of the October 7, 2020 Board meeting and the October 7, 2020 Work session. The motion carried unanimously.

VISTITOR COMMENTS: No visitor comment.

PUBLIC HEALTH UPDATE:

Mike Paul, Public Health Director presented a PowerPoint presentation showing graphs for total case and death counts globally, new confirmed cases in Oregon and Columbia County, hospitalization status, data for in-person instruction, school metrics, watch list data and OHA weekly report.

COVID -19 current numbers of confirmed and presumptive cases, with over 38.2 million globally and over one million deaths, the US has more than 7.8 million cases and over 215 thousand deaths, Oregon reported 37,780 cases and 605 deaths and Columbia County has reported 212 cumulative lab-confirmed, 21 cumulative presumptive, one death since the onset of COVID-19 and 14 hospitalizations.

Testing will be increasing with the help of Columbia Health Services (CHS), individuals will be referred to CHS by Public Health.

DISCUSSION ITEMS:

- 1. Columbia Pacific CCO, Angel Escobedo and Nancy Knopf presented a PowerPoint presentation for the Regional Health Improvement Plan (RHIP). This presentation covered Regional Care Team Outreach to at risk members, \$500,000 in emergency funding to 24 organizations in the region, community engagement in system change efforts, transparency, accountability, and high-level view of progress, how to celebrate improvements, investigate needs, and inform collaborators, indicators for each of the 8 PHIP priority areas, indicators chosen to show quarterly progress, and a deep dive into trauma care. Angel has asked if the Board of Commissioners would be in support of a letter of commitment for the Regional Health Improvement Plan that would cover Columbia County as a whole. Commissioner Tardif and Commissioner Magruder are supportive of the letter of commitment. Angel will work with staff to place on an upcoming consent agenda for approval.
- 2. John Dreeszen, Transit Interim Director presented the ODOT Grant Agreement No. 34219 to discuss the amended agreement with the State of Oregon to purchase 2 new buses. The original agreement was for class A buses, however the budget only allows for the purchase of 2 class B buses. This agreement was amended to reflect that change. The consensus of the Board is to place on an upcoming consent agenda for approval.

COMMISSIONER MAGRUDER COMMENTS:

Thanked Senator Johnson and DC6 for supplying child size masks that have been donated to Columbia County Head Start.
